2	To express sincere and heartfelt condolences upon the death of former state representative
3	Laurice Dean "Buddy" Napper of Ruston.
4	WHEREAS, it is with deep regret and profound sorrow that the members of the
5	Legislature of Louisiana have learned of the death of former state representative Laurice
6	Dean "Buddy" Napper on Wednesday, March 6, 2013, at the age of 88; and
7	WHEREAS, Mr. Napper was born in Simsboro, Louisiana, where he grew up and
8	graduated from high school; and
9	WHEREAS, Mr. Napper served honorably during World War II in the United States
10	Navy before returning home to attend Louisiana Tech University, where he lettered in
11	basketball and baseball; and
12	WHEREAS, Mr. Napper enrolled in Louisiana State University Law School in 1947
13	and upon his graduation, he returned home to Ruston and joined O.L. Waltman to form a

1	successful law practice that lasted fifty-one years; the partnership added Ray Madden and
2	Tommy Rogers and is now known as Napper, Madden and Rogers; and
3	WHEREAS, Mr. Napper was elected to the Louisiana House of Representatives in
4	1952 as the youngest member of the House and served with distinction for twelve productive
5	years; and
6	WHEREAS, upon his election to the Louisiana House of Representatives,
7	Mr. Napper used every opportunity as an able and productive legislator to serve his
8	constituency in Lincoln Parish and the citizens of the state of Louisiana in an honorable and
9	dedicated manner; and
10	WHEREAS, as a state representative, Mr. Napper steadfastly endeavored to improve
11	the welfare of the citizens of Louisiana and served on numerous committees, including
12	Affairs of the House, Appropriations, and Public Education, and as vice chairman of
13	Judiciary-A and Conservation; and
14	WHEREAS, during his tenure as a state representative and throughout his life,
15	Mr. Napper worked tirelessly to promote Ruston and the quality of life that Lincoln Parish
16	offered and was involved in many projects which brought new industry and business to the
17	area; and
18	WHEREAS, Mr. Napper was a member of the Louisiana State Bar Association for
19	fifty years, and his peers elected him to serve on the Louisiana Law Institute for more than
20	thirty-five years; and
21	WHEREAS, Mr. Napper also served as director of Lincoln Bank and Trust, coached
22	and played for an American Legion baseball team, and played semi-professional baseball
23	for the Winnsboro Red Sox; and
24	WHEREAS, Mr. Napper was an avid tennis player and golfer, and a member of
25	Trinity United Methodist Church where he served on various committees, and was a life
26	member of the board of the Louisiana Methodist Children's Home in Ruston; and
27	WHEREAS, Mr. Napper is survived by his loving and devoted wife of sixty-six
28	years, Sara Ann Baskin Napper; children, Suzan and Wallace Martin, Katherine and James
29	Freeman, and Laura and Greg Champion; grandchildren, Beth and Greg Martin, Leigh-
30	Baskin and Clay McConnell, Mark Freeman, Chris Freeman, Luke Freeman, Joshua

1 Champion, Sarah Baskin Champion, Abby Grace Champion, and Luke Martin Champion, 2 great-grandchildren, Alexandra Baskin, Parks McConnell, and Brennan, Madison, and Baker 3 Martin; one brother-in-law, William Sanders Baskin; and his nieces and nephews; and 4 WHEREAS, Mr. Napper was preceded in death by his parents, Lue Mark Napper and 5 Maude Rogers Napper, and his brother, James Harold Napper; and 6 WHEREAS, the death of Buddy Napper has left a great void and created a genuine 7 sense of sorrow in all who knew him, including the members of the legislative family, all 8 of whom mourn the loss of this wonderful man who served his state and this institution so 9 well; and 10 WHEREAS, Buddy Napper leaves behind a rich and unique legacy and is greatly 11 missed by all whose lives he touched through his commitment to public service and his 12 dedication to the citizens of Louisiana. 13 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby 14 express sincere and heartfelt condolences upon the death of former state representative 15 Laurice Dean "Buddy" Napper of Ruston, does hereby recognize and record for posterity his 16 notable accomplishments and singular contributions during his twelve-year tenure as a 17 distinguished member of the Louisiana House of Representatives, and does hereby extend 18 enduring appreciation for the pride and honor that this wonderful man will forever bring to 19 his family, the city of Ruston, the community of Lincoln Parish, the citizens of the state of 20 Louisiana, and the United States of America. 21 BE IT FURTHER RESOLVED that a suitable copy of this Resolution be transmitted
