Authorizes a contract or cooperative agreement between Iberia Parish and the Port of Iberia for the operation and management of the Acadiana Regional Airport and the Le Maire Memorial Airport.

Purpose of Bill: This measure authorizes the Iberia Parish Government to enter into a contract or cooperative endeavor agreement with the Board of Commissioners of the Port of Iberia for the operation and management of the Acadiana Regional Airport and the Le Maire Memorial Airport, as agreed to by the parties.

The measure also repeals the provision that requires the Iberia Parish Airport Authority to have six members, one of whom is an Iberia Parish citizen residing at a Jeanerette address.

EXPENDITURE EXPLANATION

There is no anticipated direct effect on governmental expenditures as a result of this measure.

According to an official with the Iberia Parish Airport Authority, there is no impact on expenditures as a result of this measure because it only changes the managing and governing structure of the airports. All funds will be accounted for in the same manner as they are presently.

There is no anticipated impact on expenditures as a result of the repeal of the board composition statute. Rather, the board will then be required to be composed as prescribed in LA R.S. 2:602(A)(1), which allows between five and nine members. Because members of the Iberia Parish Airport Authority do not receive any compensation, the number of board members has no impact on expenditures.

We contacted officials with Iberia Parish Government and the Port of Iberia. They were unable to provide details regarding fiscal impact. One official did mention that the impact may be indeterminable, if there is any impact at all.

REVENUE EXPLANATION

There is no anticipated direct effect on governmental revenues as a result of this measure.

According to an official with the Iberia Parish Airport Authority, there is no impact on revenues as a result of this measure because it only changes the managing and governing structure of the airports. All funds will be accounted for in the same manner as they are presently.

We contacted officials with Iberia Parish Government and the Port of Iberia. They were unable to provide details regarding fiscal impact. One official did mention that the impact may be indeterminable, if there is any impact at all.
