<u>A. The attorney general may revoke, suspend or deny the renewal of</u> <u>a registration on any ground on which he may refuse to grant or renew a</u> <u>registration or for violation of any provision of this Chapter.</u>

B. Any order of the attorney general denying renewal, suspending or revoking such registration shall state the grounds upon which it is based and shall not be effective until twenty days after written notice thereof has been sent by registered or certified mail to the applicant or provider at its principal place of business and such applicant or provider has failed to timely request an adjudicatory hearing in writing.

31C. Such notice of order shall also notify the applicant or provider that32it has twenty days from the date such notice is sent to make a written request33to the attorney general for an adjudicatory hearing as provided in Chapter 13-34B of Title 49 of the Louisiana Revised Statutes of 1950, R.S. 49:991 et seq.

- 1 D. The order of the attorney general shall become final if the 2 applicant or provider does not make such request for an adjudicatory hearing.

4 <u>Upon receipt of a timely request for an appeal or adjudicatory</u> 5 <u>hearing, the attorney general shall promptly forward the request to the</u> 6 <u>division of administrative law for an adjudication. The division of</u> 7 <u>administrative law shall give the applicant or provider at least twenty days</u> 8 <u>written notice of the time and place of the hearing.</u>"
