CRIME/PUNISHMENT. Authorizes sheriffs to use prisoners for manual labor upon churches and other religious buildings. (gov sig)

1	AN ACT
2	To amend and reenact R.S. 15:708(A)(2), relative to prisons and prisoners; to provide that
3	a criminal sheriff may set a prisoner to work upon any church or other religious
4	building; and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 15:708(A)(2) is hereby amended and reenacted to read as follows:
7	§708. Labor by prisoners permitted; workday release program; indemnification
8	A.(1) * * * *
9	(2)(a) Whenever a prisoner sentenced to the parish prison of any parish of
10	this state, by any court of competent jurisdiction, or a prisoner in a parish prison
11	awaiting transfer to a state correctional facility shall be willing of his own free will
12	to perform manual labor upon any <b>religious building</b> , cemetery, or graveyard or
13	work in a solid waste recycling program administered by a state agency or political
14	subdivision and approved by the sheriff, the criminal sheriff may set the prisoner to
15	work upon labor determined by the governing authority of the parishes and the
16	municipal authorities of the towns and cities.
17	(b) For purposes of this Paragraph, ''religious building'' means a church,

4	Section 2. This Act shall become effective upon signature by the governor or, if not
5	signed by the governor, upon expiration of the time for bills to become law without signature
6	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
7	vetoed by the governor and subsequently approved by the legislature, this Act shall become
8	effective on the day following such approval.

## DIGEST

Gallot (SB 8)

<u>Present law</u> provides that whenever a prisoner sentenced to the parish prison or a prisoner in a parish prison awaiting transfer to a state correctional facility is willing of his own free will to perform manual labor upon any cemetery or graveyard or work in a solid waste recycling program administered by a state agency or political subdivision and approved by the sheriff, the criminal sheriff may set the prisoner to work upon labor determined by the governing authority of the parishes and the municipal authorities of the towns and cities.

<u>Proposed law</u> retains <u>present law</u>, and adds religious buildings to the list of places upon which a criminal sheriff may set a willing prisoner to work.

<u>Proposed law</u> defines "religious building" as a church, synagogue, mosque, or other building or structure used primarily for religious worship.

Effective upon signature of the governor or lapse of time for gubernatorial action.
