EXPENDITURE EXPLANATION

There is an estimated increase in one-time expenditures in FY 14 of \$10,500 as a result of the proposed legislation. These costs consist of a one-time expenditure of approximately \$3,000 for the Office of Public Health (OPH) to privately contract for translation services for the translation of current birth certificate text into Louisiana French. These services could potentially be provided by the Council for the Development of French in Louisiana (CODOFIL), which is a state operated entity. However, OPH would have to purchase these services from CODOFIL through an interagency agreement. It is assumed that these projected costs would decrease as a result of utilizing CODOFIL over a private translation service, but the actual expenditure difference is currently unknown.

In addition, proposed legislation would required modification of the current certified birth record and certified birth card template that prints from the LA Electronic Event Registration System (LEERS) on to security paper. Installation of Louisiana French characters and symbols into LEERS will also be required for language compatibility. Based on previous document translations from English into another language within OPH and other LEERS modifications, there is a one-time estimated cost increase of approximately \$7,500 in FY 14.

REVENUE EXPLANATION

There is no anticipated direct material effect on governmental revenues as a result of this measure.
