HOUSE FLOOR AMENDMENTS

Amendments proposed by Representative Price to Engrossed House Bill No. 540 by Representative Jones

1 AMENDMENT NO. 1

2 On page 1, line 2, after "reenact" delete the remainder of the line and insert "R.S.
3 17:421.6(C), 421.8(A), and 421.9(G),

4 AMENDMENT NO. 2

5 On page 1, line 3, between "to" and "certain" change "repeal" to "modify"

6 AMENDMENT NO. 3

7 On page 1, line 7, change "R.S. 17:421.8(A) is" to "R.S. 17:421.6(C), 421.8(A), and
8 421.9(G) are"

9 AMENDMENT NO. 4

10 On page 1, between lines 7 and 8, insert the following:

11 "§421.6. Adjustments in salaries of teachers having certificates issued by the
12 National Board for Professional Teaching Standards
13 * * *
14 C. In addition to any other requirements of this Section, to receive
15 the salary adjustment provided by this Section, an otherwise eligible person
16 shall have been awarded the initial certificate issued by the National Board
17 for Professional Teaching Standards prior to July 1, 2013. However, the
18 employing school board may but shall not be required to pay the additional
19 amount to an otherwise eligible person who was awarded the initial
20 credential issued by the National Board for Professional Teaching Standards
21 on or after July 1, 2013.

23 AMENDMENT NO. 5

24 On page 1, at the beginning of line 10, change "A." to "A.(1)"

25 AMENDMENT NO. 6

26 On page 1, after line 17, insert the following:

27 "~~2~~ To receive the salary supplement provided by this Section, an
28 otherwise eligible person shall have been awarded the initial credential issued
29 by the National Board for Certified Counselors prior to July 1, 2013.
30 However, the employing school board may but shall not be required to pay
31 the additional amount to an otherwise eligible person who was awarded the
32 initial credential issued by the National Board for Certified Counselors on or
33 after July 1, 2013."

1 AMENDMENT NO. 7

2 On page 2, delete line 2, and insert the following:

3 "§421.9. Supplements to salaries of school psychologists having certain
4 credentials issued by the National School Psychology Certification
5 Board

6 * * *

7 G. In addition to any other requirements of this Section, to receive
8 the salary adjustment provided by this Section, an otherwise eligible person
9 shall be awarded the initial credential issued by the National School
10 Psychology Certification Board prior to July 1, 2013. However, the
11 employing school board may but shall not be required to pay the additional
12 amount to an otherwise eligible person who was awarded the initial
13 credential issued by the National School Psychology Certification Board on
14 or after July 1, 2013. This Subsection is enacted to determine if the salary
15 adjustment will attract and retain full-time school psychologists who hold a
16 valid ancillary certificate approved and issued by the state Department of
17 Education."
