 Provides relative to the annual report on criminal statistics published by the Louisiana Commission on Law Enforcement and the Administration of Criminal Justice  
 The proposed legislation removes the requirement that the Louisiana Commission on Law Enforcement present a printed copy of an annual report on criminal statistics to all members of the legislature and instead requires a printed copy to be distributed to the chairman of the House Committee on the Administration of Criminal Justice, and the senate chairman of Judiciary C and as many others as may be requested. The legislation also requires the commission to place the report on its web-site.

**EXPENDITURE EXPLANATION**

Implementation of the proposed legislation is anticipated to reduce printing and mailing costs by an indeterminable amount for the annual report on criminal statistics published by the Louisiana Commission on Law Enforcement. The proposed legislation deletes the requirement that all members of the legislature receive a printed copy of the report and instead requires the agency to provide printed copies of the report to the governor, the chairman of the House Committee on the Administration of Criminal Justice, the chairman of the Senate committee on Judiciary C and to others when requested. The proposed legislation also requires the agency to place a copy of the report on the internet. Although availability of the report on the agency's web-site is anticipated to reduce the need for printed copies, the Legislative Fiscal Office is not able to anticipate the number of printed copies that may be requested. The agency's FY 14 budget includes a total of \$7,250 for printing (\$6,430) and mailing (\$830) the report.

**REVENUE EXPLANATION**

There is no anticipated direct material effect on governmental revenues as a result of this measure.
