GOVERNOR. Denounces the executive budget and requests the governor to restore funds to the New Orleans Exhibition Hall Authority - Morial Convention Center.

1	A RESOLUTION
2	To denounce the Governor's Executive Budget for sweeping one hundred million dollars
3	from the Morial Convention Center and to urge and request the Governor to restore
4	these funds and support responsible budgeting through the use of stable, reoccurring
5	funds and avoiding the reliance on one-time fund raids.
6	WHEREAS, the New Orleans Exhibition Hall Authority - Morial Convention Center
7	receives considerable proceeds from a tax on the sale of hotel and motel rooms in the City
8	of New Orleans; and
9	WHEREAS, the volume of hotel sales is concurrent with the overall health of the
10	tourism and convention industry; and
11	WHEREAS, the tourism and convention industry as a whole is a dynamic engine of
12	economic growth, empowerment, and innovation for the entire New Orleans region,
13	providing jobs and opportunities for thousands of Louisianians; and
14	WHEREAS, New Orleans' tourism industry welcomed 9.01 million visitors in 2012,
15	record numbers not seen by the city in nearly ten years; and
16	WHEREAS, the growth of tourism, and the hotel/motel tax revenue it creates, is the
17	result of the dedicated, cooperative efforts of tourism professionals, local public officials,
18	entrepreneurs, businesses and citizens in and around New Orleans; and

does hereby denounce the Governor's executive budget.
