

SENATE COMMITTEE AMENDMENTS

Amendments proposed by Senate Committee on Local and Municipal Affairs to Original Senate Bill No. 207 by Senator Morrell

1 AMENDMENT NO. 1

2 On page 1, line 2, between "To" and "amend" insert "enact R.S. 33:2588 and to" and after  
3 "33:2391" insert ", 2471, and 2591"

4 AMENDMENT NO. 2

5 On page 1, line 6, between "Section. 1" and "R.S." insert "R.S. 33:2588 is hereby enacted  
6 and" and change "is" to ", 2471, and 2591 are"

7 AMENDMENT NO. 3

8 On page 1, after line 12, add:

9 **"C. In the event that the civil service of any city pursuant to this Part is**  
10 **determined by a final judgment of a court of competent jurisdiction to not be**  
11 **subject to this Part, the civil service of the city shall be subject to the**  
12 **jurisdiction of the state civil service system.**

14 §2471. Applicability

15 **A.** This Part applies to any municipality which operates a regularly paid fire and  
16 police department and which has a population of not less than thirteen thousand nor  
17 more than two hundred fifty thousand according to the latest regular federal census  
18 for which the official figures have been made public.

19 **B. In the event that the civil service of any municipality pursuant to this Part**  
20 **is determined by a final judgment of a court of competent jurisdiction to not**  
21 **be subject to this Part, the civil service of the municipality shall be subject to the**  
22 **jurisdiction of the state civil service system.**

24 **§2588. Determination that certain constitutional provisions are not applicable**  
25 **to city**

26 **In the event that the civil service of any city pursuant to the city civil service**  
27 **provisions of Part I of Article X of the Constitution of Louisiana is determined**  
28 **by a final judgment of a court of competent jurisdiction to not be subject to**  
29 **such provisions, the civil service of the city shall be subject to the jurisdiction**  
30 **of the state civil service system.**

32 §2591. System of classified service

33 **A.** There is created in every municipality having a population between 250,000 and  
34 500,000 a classified civil service embracing the positions of employment, the  
35 officers and the employees of the fire and police services. The classified civil  
36 service herein provided for shall be established, operated and governed in all respects  
37 solely by the provisions of Section 15.1 of Article XIV of the Constitution of  
38 Louisiana.

39 **B. In the event that the civil service of any municipality pursuant to this Part**  
40 **is determined by a final judgment of a court of competent jurisdiction to not**  
41 **be subject to this Part, the civil service of the municipality shall be subject to the**  
42 **jurisdiction of the state civil service system."**
