
HOUSE COMMITTEE AMENDMENTS

Amendments proposed by House Committee on Appropriations to Original House Bill No. 1 by Representative Fannin

1 AMENDMENT NO. 1

2 On page 11, line 17, change "\$464,840,279" to "\$436,740,279"

3 AMENDMENT NO. 2

4 On page 12, between lines 3 and 4, insert the following:

5 "D. The commissioner of administration is hereby authorized and directed to reduce the
6 State General Fund (Direct) appropriations contained in each department and budget unit
7 contained in this Act to achieve a State General Fund (Direct) savings of at least
8 \$16,184,283 from the reduction of funding for vacant positions. The commissioner of
9 administration is hereby further authorized to reduce the authorized positions associated with
10 such funding."

11 AMENDMENT NO. 3

12 On page 74, between lines 17 and 18, insert the following:

13 "The commissioner of administration is hereby authorized and directed to adjust the means
14 of financing for the Traffic Enforcement Program by reducing the appropriation out of the
15 State General Fund by Statutory Dedications out of the Transportation Trust Fund by
16 \$28,100,000.

17 Payable out of the State General Fund by	
18 Statutory Dedications out of the Riverboat Gaming	
19 Enforcement Fund to the Traffic Enforcement	
20 Program for operations	\$ 28,100,000"

21 AMENDMENT NO. 4

22 On page 141, between lines 12 and 13, insert the following:

23 "The commissioner of administration is hereby authorized and directed to adjust the means
24 of financing in this agency by reducing the appropriation out of the State General Fund by
25 Statutory Dedications out of the Overcollections Fund by \$28,100,000.

26 Payable out of the State General Fund (Direct)	
27 to the Board of Regents	\$ 18,100,000

28 Payable out of the State General Fund by	
29 Statutory Dedications out of the Rapid Response	
30 Fund to the Board of Regents, notwithstanding	
31 any other provision of the law to the contrary,	
32 and specifically notwithstanding R.S. 51:2361	\$ 10,000,000"

33 AMENDMENT NO. 5

34 On page 141, on line 36, deletes "464,840,279" and replaces with "\$436,740,279"

1 AMENDMENT NO. 6

2 On page 194, between lines 50 and 51, insert the following:

3 "The commissioner of administration is hereby authorized and directed to adjust the means
4 of financing for the Minimum Foundation Program by reducing the appropriation out of the
5 State General Fund (Direct) by \$1,915,717."

6 AMENDMENT NO. 7

7 On page 206, after line 44, insert the following:

8 "The commissioner of administration is hereby authorized and directed to adjust the means
9 of finance for the Debt Service and State Commitments Program by reducing the
10 appropriation out of the State General Fund by Statutory Dedications out of the Rapid
11 Response Fund by \$10,000,000."
