17 On page 3, between lines 12 and 13, insert the following:

18 **"F. The board may issue a registration as a counselor intern to an applicant**  
19 **who meets qualifications established by the board. The board shall adopt rules**  
20 **pursuant to the Administrative Procedure Act establishing such qualifications**  
21 **and requirements as necessary for the adequate protection of the health and**  
22 **welfare of the residents of this state. Such qualifications shall include, but not**  
23 **be limited to, that the applicant shall be at least twenty-one years old, of good**  
24 **moral character, in compliance with all applicable provisions of law or board**  
25 **regulations, and possess a graduate degree the substance of which is mental**  
26 **health counseling."**

30 On page 3, line 21, change "**citizens**" to "**residents**"

1 AMENDMENT NO. 10

2 On page 6, between lines 2 and 3, insert the following:

3 **"C. The board may issue a registration as a marriage and family therapist**  
4 **intern to an applicant who meets qualifications established by the board. The**  
5 **board shall adopt rules pursuant to the Administrative Procedure Act**  
6 **establishing such qualifications and requirements as necessary for the adequate**  
7 **protection of the health and welfare of the residents of this state. Such**  
8 **qualifications shall include, but not be limited to, the applicant shall be at least**  
9 **twenty-one years old, of good moral character, in compliance with applicable**  
10 **provisions of law or board regulations, and possess a graduate degree in**  
11 **marriage and family therapy, or a related clinical mental health field from a**  
12 **regionally accredited institution of higher education, or a certificate from a**  
13 **postgraduate training institute in marriage and family therapy."**
