5	Montgomery, Louisiana; and
6	WHEREAS, Mr. Jackson went on to attend Northwestern State University in
7	Natchitoches, Louisiana majoring in business management; and
8	WHEREAS, Frank Jackson honorably served his country as a member of the United
9	States Army from June 1979 to March 1985; and
10	WHEREAS, Mr. Jackson continues to serve today as a member of the Louisiana
11	National Guard, which he joined in June 1985; and
12	WHEREAS, Mr. Jackson answered the call on his life to preach the Gospel and
13	became licensed to preached in September 1987; and

2	and a supply logistic management specialist; and
3	WHEREAS, from November 1991 to January 2000, Pastor Jackson served as the
4	shepherd of Calvary Baptist Church in Colfax, Louisiana; and
5	WHEREAS, from January 2000 to January 2003, he was the spiritual head of
6	Sunlight Missionary Baptist Church in Pineville, Louisiana; and
7	WHEREAS, Pastor Jackson faithfully and dutifully served for almost ten years as
8	the pastor of Providence Family Ministry in Alexandria, Louisiana; and
9	WHEREAS, Pastor Jackson has recently been named the pastor of St. Matthew
10	Baptist Church in Boyce, Louisiana; and
11	WHEREAS, Pastor Jackson is married to the lovely Annie Jackson and is the proud
12	father of four children and grandfather of numerous grandchildren; and
13	WHEREAS, together Pastor Jackson and his wife, Annie, serve as board members
14	of the Seeds of Harvest Ministry, a nonprofit organization that services senior citizens in the
15	Pineville, Alexandria, and Boyce communities; and
16	WHEREAS, Pastor Jackson divides his time to work with many organizations
17	including the Pineville Concerned Citizen, Inc.; Central Louisiana Ministerial Association;
