COURTS/COURT COSTS: Provides for an increase in certain fees for the Orleans Parish Juvenile Court

1	AN ACT
2	To enact R.S. 13:1595.3, relative to court costs and fees; to provide for additional court costs
3	for certain filings in the Orleans Parish Juvenile Court; to provide for the use of
4	additional funds; to establish a fee on filings in the Orleans Parish Juvenile Court;
5	to provide for the remittance of the fee to be used for the maintenance of the Orleans
6	Parish Juvenile Court facility; and to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 13:1595.3 is hereby enacted to read as follows:
9	<u>§1595.3.</u> Fees; enumeration
10	A. In addition to all other fees or costs provided by law, the clerk of court
11	for the Orleans Parish Juvenile Court shall collect the following fees from every
12	person who is not otherwise exempted by law from the payment of court costs:
13	(1) For service of process in adoption cases within Orleans Parish, a fee of
14	sixty dollars and for service of process in adoption cases made outside of Orleans
15	Parish, a fee of eighty-five dollars. All fees collected pursuant to this Paragraph
16	shall be expended by the Orleans Parish Juvenile Court to defray the expenses
17	associated with service of process for adoption cases.
18	(2) For filing and docketing each supplemental and amended petition in
19	adoption cases, a fee of one hundred ten dollars. All fees collected pursuant to this
20	Paragraph shall be expended by the court to defray the cost of processing

1	supplemental and amended petitions associated with adoption cases in the Orleans
2	Parish Juvenile Court.
3	(3) For filing and docketing each petition for adoption, an increase of one
4	hundred twenty-five dollars. All fees collected pursuant to this Paragraph shall be
5	expended by the court to defray the cost of processing pleadings and the preparation
6	and activities associated with adoption cases.
7	(4) For filing and docketing each motion to terminate parental rights in
8	adoption cases, an increase of seventy-five dollars. All fees collected pursuant to
9	this Paragraph shall be expended by the court to defray the administrative and
10	operational costs and the clerk's processing costs associated with proceedings related
11	to the termination of parental rights associated with adoption cases.
12	B. In addition to all other fees or costs provided by law, the clerk of court for
13	the Orleans Parish Juvenile Court shall collect a fee of ten dollars from every person
14	filing any action, suit, motion, or rule to show cause on the docket of the Orleans
15	Parish Juvenile Court and who is not otherwise exempted by law from the payment
16	of court costs. All fees collected pursuant to this Subsection shall be remitted by the
17	clerk to the director of finance for the city of New Orleans to be used solely for the
18	maintenance of the Orleans Parish Juvenile Court facility.

Abstract: Provides for additional court costs and establishment of fees in the Orleans Parish Juvenile Court.

<u>Proposed law</u> requires the clerk of the Orleans Parish Juvenile Court to collect the following fees in all adoption cases in addition to any other fees or costs from any person who is not exempt from paying court costs:

- (1) \$60 for service of process in Orleans Parish and \$85 for service of process outside of Orleans Parish.
- (2) \$110 for filing and docketing each supplemental and amended petition.
- (3) An additional \$125 for filing and docketing each petition for adoption.

(4) An additional \$75 for filing and docketing each motion to terminate parental rights.

<u>Proposed law</u> requires the clerk of court for the Orleans Parish Juvenile Court to collect a \$10 fee in addition to all other fees provided for in <u>present law</u> or <u>proposed law</u> from any person who is filing certain pleadings and not exempted from the payment of court costs to be remitted by the clerk to the director of finance for the city of New Orleans to be used solely for the maintenance of the Orleans Parish Juvenile Court facility.

Summary of Amendments Adopted by House

Committee Amendments Proposed by House Committee on Judiciary to the original bill.

- 1. Added provisions that all additional fees collected pursuant to <u>proposed law</u> shall apply in adoption cases to defray the costs associated with adoption cases.
- 2. Required the additional \$10 fee to be remitted by the clerk to the director of finance for the city of New Orleans to be used solely for the maintenance of the Orleans Parish Juvenile Court facility.
