6 On page 174, line 23, delete "Contracts" and insert the following:

7 "The Louisiana Stadium and Exposition District may apply up to \$10,000,000 of  
8 these appropriations to reimburse the New Orleans Hornets NBA, LLC for costs  
9 incurred in constructing a new training facility as a private work as contemplated by  
10 the Amended and Restated Arena Use Agreement dated July 1, 2012; but, otherwise,  
11 contracts"
