A CONCURRENT RESOLUTION

2	To commend the Metairie Park Country Day Cajuns upon winning the 2013 Class 1A state
3	basketball championship.
4	WHEREAS, on March 7, 2013, the Metairie Park Country Day Cajuns boys'
5	basketball team completed a sensational season, earning the title of 2013 Class 1A state
6	champions by defeating Arcadia High School by a score of 60-54 to win the state
7	championship game at Fant-Ewing Coliseum at the University of Louisiana at Monroe; and
8	WHEREAS, the championship win was the third straight overtime playoff win for
9	the Cajuns and the culmination of another unforgettable season in which the team finished
10	with a 22-10 record; and
11	WHEREAS, the championship win was the first 1A crown for the Cajuns since 2009
12	and their fourth boys' basketball trophy overall; and
13	WHEREAS, the members of the team performed at the highest level of excellence
14	throughout the 2013 season and playoffs, and each of these great Cajuns deserves
15	recognition for his vital contribution to the winning effort; and
16	WHEREAS, the Cajuns rallied from a twenty point deficit in the second half and did
17	not allow Arcadia to score a field goal in the final ten minutes of play; and
18	WHEREAS, freshman guard Michael Corchiani, who was awarded the
19	Championship's Outstanding Player award, finished with fifteen points, including four three-
20	pointers; Scott Plaisance added fourteen points, ten rebounds, and five blocks for the Cajuns;
21	and Kent McGuire added eleven points and six rebounds; and
