ASSESSORS. Authorizes each assessor to increase his compensation by up to 4% each calendar year for four years beginning 2013. (7/1/13)

2 To amend and reenact R.S. 47:1907(A)(1) and to enact R.S. 47:1907(K), relative to 3 assessors; to authorize assessors to increase their compensation up to four percent for four calendar years; to provide for an effective date; and to provide for related 4 5 matters. R.S. 47:1907(A)(1) is hereby amended and reenacted and R.S. 47:1907 9 (K) is hereby enacted to read as follows: 10 §1907. Salaries 11 A.(1) Notwithstanding any other provision of law to the contrary, except the provisions of Subsection H, I, J, and K, of this Section, in the performance of all 12 13 duties required of them by law, the assessors of the various parishes shall receive an annual compensation, to be paid monthly on their own warrant, based on the 14 applicable population of the respective parishes, not to exceed the compensation 15 schedule provided for in this Paragraph according to the latest decennial United 16 States Census or the population estimates published pursuant to the United States 17

Bureau of the Census Federal State Cooperative Program for Population Estimates.

K. In addition to all other forms of compensation which are authorized for assessors under the provisions of this Section, each assessor may increase his annual compensation by up to four percent each calendar year for four calendar years, beginning calendar year 2013.

Section 2. This Act shall become effective on July 1, 2013.

<u>Present law</u> provides that parish tax assessors shall receive annual compensation based upon the following compensation schedule depending on the population of the parish in which they serve:

Population	Compensation
(a) Greater than 250,000	\$108,290
(b) 50,001 to 249,999	\$ 98,290
(c) 50,000 or less	\$ 88,290

<u>Present law</u> provides a one-time increase in compensation of 7% of the assessor's annual salary upon his certification as a certified Louisiana assessor (CLA).

<u>Present law</u> provides that, beginning on July 1, 1999, the annual compensation of each assessor shall be increased by \$10,000.

<u>Present law</u>, beginning on July 1, 2003, authorized each assessor to increase his annual compensation by up to \$7,000.

<u>Proposed law</u> authorizes each assessor to increase his annual compensation by up to 4% each calendar year for four calendar years, beginning calendar year 2013.

Effective July 1, 2013.
