STUDENT/TUITION: (Constitutional Amendment) Exempts public postsecondary education tuition and fees from requirements for imposing a new or increasing an existing fee

1	A JOINT RESOLUTION
2	Proposing to add Article VII, Section 2.1(C) of the Constitution of Louisiana, relative to
3	requirements in relation to the imposition of or increase in fees and civil fines; to
4	provide exceptions relative to public postsecondary education tuition and fees; to
5	provide for submission of the proposed amendment to the electors; and to provide
6	for related matters.
7	Section 1. Be it resolved by the Legislature of Louisiana, two-thirds of the members
8	elected to each house concurring, that there shall be submitted to the electors of the state of
9	Louisiana, for their approval or rejection in the manner provided by law, a proposal to add
10	Article VII, Section 2.1(C) of the Constitution of Louisiana, to read as follows:
11	§2.1. Fees and Civil Fines; Limitation; Exceptions
12	Section 2.1.
13	* * *
14	(C) The provisions of Paragraph (A) of this Section shall not apply to tuition
15	or fees imposed by a postsecondary education management board.
16	Section 2. Be it further resolved that this proposed amendment shall be submitted
17	to the electors of the state of Louisiana at the statewide election to be held on November 4,
18	2014.

CODING: Words in struck through type are deletions from existing law; words <u>underscored</u> are additions.

1	Section 3. Be it further resolved that on the official ballot to be used at the election
2	there shall be printed a proposition, upon which the electors of the state shall be permitted
3	to vote YES or NO, to amend the Constitution of Louisiana, which proposition shall read as
4	follows:
5	Do you support an amendment to remove public postsecondary education
6	tuition and fees from the requirement that the imposition of a new fee or fee
7	increase requires the enactment of a law by a two-thirds vote of the
8	legislature? (Adds Article VII, Section 2.1(C))

Abstract: Removes postsecondary education tuition and fees from the requirement that new fees or increases be enacted by a law by a 2/3 vote by the legislature.

<u>Present constitution</u> provides that any new fee or civil fine or increase in an existing fee or civil fine imposed by any board, department, or agency of the state shall require the enactment of a law by 2/3 vote of the elected members of each house of the legislature.

<u>Present constitution</u> specifies that this requirement does not apply to any department which is constitutionally created and headed by an officer who is elected by majority vote of the electorate of the state.

<u>Proposed constitutional amendment</u> retains <u>present constitution</u> and provides that this requirement shall not apply to tuition or fees imposed by a public postsecondary education management board.

Provides for submission of the proposed amendment to the voters at the statewide election to be held Nov. 4, 2014.
