SENATE CONCURRENT RESOLUTION NO. 66

LEGIS POWERS/FUNCTIONS. Recognizes Avery's Angels Gastroschisis Foundation and July 30, 2013, as Gastroschisis Awareness Day.

A CONCURRENT RESOLUTION

2 To recognize Avery's Angels Gastroschisis Foundation for its community service and support provided to those patients affected by the disease and to declare July 30, 3 2013, and for every year thereafter as Gastroschisis Awareness Day in Louisiana. 4 5 WHEREAS, gastroschisis is a serious congenital birth defect affecting one infant in every two thousand births; it presents as a protrusion of intestinal lining through the stomach 6 7 wall; and these cases often require immediate surgery and continuous medical monitoring 8 for a prolonged time period; and 9 WHEREAS, Avery's Angels Gastroschisis Foundation was established to provide 10 support for families experiencing the disease; based in Raleigh, North Carolina, and 11 affiliated with the University of North Carolina Hospital, the foundation seeks to fund research to find the cause and the eventual cure to this malady; and 12 13 WHEREAS, the all-volunteer nonprofit organization was founded by Meghan Hall, mother of Avery John Rauen, a beautiful son born with the affliction who lived to only three 14 months of age; his death on July 30, 2009, marks the establishment of an overt movement 15 16 to address the needs of patients and to disseminate valuable information about gastroschisis treatment: and 17 WHEREAS, many young Americans living with gastroschisis often suffer 18

1	debilitating conditions such as failure to thrive, slow growth, short bowel syndrome, and are
2	subject to multiple surgeries and possible organ transplants; and
3	WHEREAS, Avery's Angels Gastroschisis Foundation seeks to organize a perpetual
4	nationwide observance of Gastroschisis Awareness Day on July 30, 2013, in an effort to
5	bring added emphasis to the need for research funding and patient support for those affected
6	by the disease.
7	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
8	recognize Avery's Angels Gastroschisis Foundation for the community service and support
9	provided to patients and families affected by the disease and further recognizes July 30,

2013, and every year thereafter, as Gastroschisis Awareness Day.
