HOUSE FLOOR AMENDMENTS

Amendments proposed by Representative Stuart Bishop to Engrossed House Bill No. 720
by Representative Abramson

1 AMENDMENT NO. 1

2 On page 4, between lines 13 and 14, insert the following:

3 "Section 6. The commissioner of the division of administration,
4 notwithstanding any other provision of law to the contrary, is hereby authorized and
5 empowered to convey, transfer, assign, lease or deliver any interest, excluding
6 mineral rights, the state may have to the following described properties to Phyllis
7 Marks and Michael Marks, but only upon the condition that the Atchafalaya Land
8 Corporation or its successors in title reject their option to purchase their former
9 interest pursuant to R.S. 41:1338:

10 That certain tract of land containing 0.204 acres, being Lot 62A located in
11 Section 11, Township 9 South, Range 7 East, St. Martin Parish, Louisiana
12 and being more particularly described as follows:

13 COMMENCING at the Northwestern corner of Lot 62 (1/2" I.P.) as shown
14 on the Atchafalaya Land Corporation Plat by C. L. Jack Stelly, LA PLS No.
15 358, dated June 27, 1997; Thence in a Southeasterly direction 375.33 feet to
16 the POINT OF BEGINNING (5/8" I.R.); Thence North 86 degrees 37
17 minutes 29 seconds East 125.00 feet; Thence South 40 degrees 27 minutes
18 04 seconds West 154.78 feet; Thence North 19 degrees 35 minutes 34
19 seconds West 48.34 feet; Thence North 42 degrees 08 minutes 29 seconds
20 West 83.67 feet (set hole in conc.); Thence North 86 degrees 37 minutes 29
21 seconds East 48.06 feet (5/8" I.R.) to the POINT OF BEGINNING.

22 Said property bordered Northerly by Michael Marks, Westerly by barrow
23 ditch, Southerly by barrow ditch and State of Louisiana, Easterly by State of
24 Louisiana and is shown on "PLAT OF SURVEY SHOWING PROPERTY
25 TO BE ACQUIRED BY MICHAEL MARKS LOCATED IN SECTION 11,
26 TOWNSHIP 9 SOUTH, RANGE 7 EAST, ST. MARTIN PARISH" by
27 Brandon S. Breaux, LA PLS No. 4946 dated October 26, 2008.

28 Section 7. The commissioner of the division of administration is hereby
29 authorized to enter into such agreements, covenants, conditions, and stipulations and
30 to execute such documents as necessary to properly effectuate any conveyance,
31 transfer, assignment, lease or delivery of title, excluding mineral rights, to the
32 property described in Section 6 of this Act, and as more specifically described in any
33 such agreements entered into and documents executed by and between the
34 commissioner of the division of administration and Phyllis Marks and Michael
35 Marks, in exchange of consideration proportionate to the appraised value of the
36 property.

37 AMENDMENT NO. 2

38 On page 4, at the beginning of line 14, change "Section 6." to "Section 8."
