9	of 4-1 against the first and second seeded teams; and
10	WHEREAS, Tatiana Larina and Andrea Nedorostova won the number one doubles
11	match with a score of 8-3; and
12	WHEREAS, Ms. Nedorostova serves as the team's captain and only senior, and she
13	has demonstrated exceptional leadership on and off the court; and

15	careers but in the classroom as well, which is evident in the team's cumulative grade point
