21	A.(1) There is hereby created, within the Department of Agriculture and
22	Forestry, the Louisiana Feed, Fertilizer, and Agricultural Liming Chemistry and
23	Seed Commission. to be composed of the commissioner of agriculture and forestry,
24	the director of the Louisiana Agricultural Experiment Station, the director of the
25	Louisiana Cooperative Extension Service, the president of Louisiana Farm Bureau
26	Federation, Inc., the chairmen of the Livestock Advisory Committee and the Dairy
27	Advisory Committee of the Louisiana Farm Bureau Federation, Inc., the president
28	of the Louisiana Thoroughbred Breeder's Association, the president of the Louisiana
29	Cattlemen's Association, the president of the Louisiana Ag Industries Association,
30	or their duly authorized representatives, a person who owns or operates a feed

3	shall consist of seven members as follows:
4	(1) The commissioner of agriculture and forestry or his designee.
5	(2) One member and an alternate, representing the Louisiana
6	Agricultural Experiment Station, appointed by the commissioner and who shall
7	serve at the pleasure of the commissioner.
8	(3) One member and an alternate, representing the Louisiana
9	Cooperative Extension Service, appointed by the commissioner and who shall
10	serve at the pleasure of the commissioner.
11	(4) The president of Louisiana Farm Bureau Federation, Inc. or his
12	designee, subject to the approval of the commissioner.
13	(5) One member representing the seed industry appointed by the
14	commissioner from a list of three nominees submitted by the Louisiana Ag
15	Industries Association who shall serve at the pleasure of the commissioner.
16	(6) One member representing the fertilizer industry appointed by the
17	commissioner from a list of three nominees submitted by the Louisiana Ag
18	Industries Association who shall serve at the pleasure of the commissioner.
19	(7) One member representing the feed industry appointed by the
20	commissioner from a list of three nominees submitted by the Louisiana Ag
21	Industries Association and a list of three nominees submitted by the Louisiana
22	Cattlemen's Association who shall serve at the pleasure of the commissioner.
23	(2) The prospective appointee who owns or operates a feed business which
24	is not a member of the Louisiana Ag Industries Association and the prospective
25	appointee who shall be an independent feed manufacturer domiciled in Louisiana
26	shall be appointed by and shall serve at the pleasure of the governor. Each
27	appointment by the governor shall be submitted to the Senate for confirmation.
28	B. The commissioner shall be ex officio chairman of the commission and
29	shall be its chief executive officer responsible for enforcement of this Chapter. He
30	is empowered to employ personnel, to purchase supplies, and to make such other

2	appoint a director and assistant director of the feed program, and a director and an
3	assistant director of the fertilizer program, and a director and assistant director of
4	the seed program who shall be appointed by the commission, subject to the
5	approval of the commissioner. The directors and assistant directors shall be in the
6	unclassified service. All employees of the commission shall be under the
7	supervision and direction of the commissioner.

9	§1407. Disposition of funds <u>; Feed and Fertilizer Fund</u>
10	A.(1) All fees, assessments, penalties, and all other funds received by the
11	commission under the provisions of Parts II and III of this Chapter, except for the
12	deficiency assessments paid to the purchaser-user as provided for in R.S. 3:1415
13	and the consumer as provided for in R.S. 3:1430.13 and subject to the exceptions
14	contained in Article VII, Section 9 of the Constitution of Louisiana, shall be
15	deposited immediately upon receipt into the state treasury and shall be credited to the
16	Bond Security and Redemption Fund.
17	(2) Out of the funds remaining in the Bond Security and Redemption Fund
18	after a sufficient amount is allocated from that fund to pay all obligations secured by
19	the full faith and credit of the state which become due and payable within any fiscal
20	year, the treasurer, prior to placing the remaining funds in the state general fund,
21	shall pay an amount equal to the total amount of funds paid into the state treasury by
22	the commission under the provisions of Parts II and III of this Chapter into a
23	special fund which is hereby created in the state treasury and designated as the "Feed
24	and Fertilizer Fund".
25	(3) All unexpended and unencumbered monies in the fund at the end of each
26	fiscal year shall remain in the fund. The monies in the fund shall be invested by the
27	treasurer in the same manner as monies in the state general fund. All interest earned
28	on monies from the fund invested by the state treasurer shall be deposited in the
29	fund.
30	B. Subject to appropriation, the monies in the Feed and Fertilizer Fund shall

22	(4) "Commission" means the <u>Agricultural Chemistry and</u> Seed
23	Commission.

25	(17) <u>"Minor violation" means a violation of noncompliance that does not</u>
26	create a competitive disadvantage for licensees in full compliance, is not a
27	violation that adversely affects human health, safety or the environment, is not
28	<u>a violation performed with malicious, deliberate or fraudulent intent, and is not</u>
29	a repetitive violation.
30	(18) "Mixed seeds" are seeds of more than one kind or variety when each

5	(20)(21) "Other crop seeds" are the seeds of all kinds or varieties not of the
6	kind or variety declared on the label.
7	(21)(22) "Person" means any individual, firm, corporation, association, or
8	partnership.
9	(22)(23) "Prohibited noxious weed seeds" means any weed seeds which that
10	are prohibited from being present in agricultural, vegetable, flower, tree, or shrub
11	seed.
12	(23)(24) "Pure seeds" are all seeds of the kind and variety under
13	consideration, whether shriveled, cracked, or otherwise injured, and pieces of seeds
14	larger than one-half the original size.
15	(24)(25) "Retail seedsman" means any person who sells seed at retail directly
16	to the consumer either in quantities of not less than one pound or any quantity
17	including closed containers of less than one pound.
18	(25)(26) "Seed" is a propagative part of a plant capable of producing a new
19	plant, including but not limited to those parts commonly referred to as seeds, bulbs,
20	roots, tubers, and other propagating stock.
21	(26)(27) "Stop order" is any written or printed notice given by the
22	commissioner of the Department of Agriculture and Forestry or his authorized
23	agents, to the person with a lot of seed, directing the person not to sell or offer for
24	sale the seed until the requirements of this Chapter Part and regulations promulgated
25	hereunder have been complied with and a written release is issued. Such seeds may
26	be released for sale as feed.
27	(27)(28) "Treated" means that the seed has received an application of a
28	substance or that it has been subjected to a process for which a claim is made.
29	(28)(29) "Variety" is a subdivision of a kind characterized by growth, plant,
30	fruit, seed, or other characteristic by which it can be differentiated from other seeds

7	§1433. Powers and duties of seed responsibilities of commission
8	A. The commission shall:
9	(1)(a) * * * *
10	(b) Establish the standards and tolerances to be allowed in the administration
11	of this Chapter Part;

13	(f) Make all rules and regulations pertaining to the enforcement of this
14	Chapter Part.

16	(3) In making rules and regulations, give consideration to the following with
17	respect to each kind of seed or other propagating stock regulated by this Chapter

2	The commissioner shall:

4	by the commission.
5	(2) Sample, inspect, test, and make analyses of agricultural, vegetable, and
6	flower seeds transported, offered for sale, sold, or distributed in Louisiana for
7	planting purposes; determine whether the seeds are in compliance with this Chapter
8	Part and with rules and regulations made under this Chapter Part; and notify
9	promptly the person who transported, distributed, sold, or offered for sale the seeds
10	of any violation.

17	The commissioner may:

21	regular business hours, any public or private premises where agricultural, vegetable,

23	(3) Issue and enforce a stop order to the person with a lot of seed or other
24	propagating stock which that the commissioner finds, or has good reason to believe,
25	is in violation of this Chapter Part or the rules and regulations made under this

28	other analysts, and other personnel whose work he shall direct and supervise; and
29	incur such other expenses necessary to comply with this Chapter Part.

15	Each container of agricultural, vegetable, or flower seeds, or other
16	propagating stock, which that is sold or offered for sale in Louisiana for planting
17	purposes shall bear thereon or have attached thereto in a conspicuous place a label
18	plainly written or printed in the English language. The label shall give the following
19	information:
20	(1) For all agricultural, vegetable, and flower seeds treated as defined in this
21	Chapter Part for which a separate label may be used:
22	* * *
23	(2) On agricultural seeds:
24	(a) Except as otherwise provided herein, the commonly accepted name of the
25	kind and variety of each agricultural seed component in excess of five percent of the
26	whole, and the percentage of weight of each in the order of its predominance. The
27	provisions of this Subparagraph shall not prohibit the sale of wheat and oat seeds
28	which that are labeled "variety not stated" and which that meet the other
29	requirements of this Chapter Part. The commission may adopt rules and regulations

11	A. Every person, except persons exempt by R.S. 3:1446 3:1445, who sells,
12	distributes, or offers or handles for sale agricultural, vegetable, or flower seeds or
13	other propagating stock of one pound or more in weight shall register with the
14	commissioner as a seed dealer. Every seed dealer shall register the number and
15	location of each place of business at which the seeds are sold, distributed, or offered
16	or handled for sale. The commissioner shall issue to the registered seed dealer a
17	license to engage in the business.

19	§1438. Suspension or revocation of seed dealer license
20	Any licensee who violates any of the provisions of this Chapter Part or the
21	regulations adopted under the provisions of this Chapter Part shall be subject to
22	having his license suspended, revoked, or placed on probation, in addition to any
23	other penalties authorized by this Chapter Part.

25	§1440. Stop order
26	A stop order shall prohibit further sale, exchange, movement, or distribution
27	of seeds included in the order until the commissioner is satisfied that this Chapter
28	<u>Part</u> and rules and regulations of the commission have been complied with and the
29	commissioner has issued a written release to the person with such seed. After a stop
30	order is given, the person receiving the stop order shall have thirty days within which

5	When the commissioner issues a stop order to a person with a lot of seed and
6	such person fails to comply with this Chapter Part or the regulations of the
7	commission, the commissioner shall seize the lot of seed and shall destroy the lot
8	within thirty days, or shall dispose of it in the manner prescribed by the rules and
9	regulations made by the commission.
10	§1443. Disclaimer or nonwarranty clause of no effect
11	The use of a disclaimer or nonwarranty clause in any invoice, advertisement,
12	or label pertaining to seeds shall not exempt a person from the provisions of this
13	Chapter Part.
14	§1444. Prohibitions
15	No person shall:
16	(1) Sell, offer for sale, transport, or distribute any agricultural, vegetable, or
17	flower seeds unless the seeds have been tested in accordance with the rules and
18	regulations adopted by the Agricultural Chemistry and Seed Commission. The
19	commission by rule may require information relative to the test to be affixed to the
20	packaging of the seeds.
21	(2) Sell, offer for sale, transport, or distribute any agricultural, vegetable or
22	flower seeds which that are not labeled in accordance with this Chapter Part or
23	which <u>that</u> have false or misleading labeling.

25	(4) Sell, offer for sale, transport, or distribute any agricultural seeds
26	containing noxious weed seeds, subject to tolerances and methods of determinations,
27	in excess of those prescribed under this Chapter Part.
28	(5) Detach, deface, destroy, or use a second time any label provided for in

6	(1) To common carriers with respect to seeds transported in the ordinary
7	course of business as a carrier. R.S. 3:1436 shall apply to carriers engaged in
8	processing or merchandising seeds subject to the provisions of this Chapter Part.
9	* * *
10	(3) To agricultural seeds when grown, sold, and delivered by the producer
11	on his own premises when the growing of crops for reproductive purposes is not the
12	primary farming occupation of the producer. If the seeds are advertised for sale
13	through any medium or if the seeds are delivered by a common carrier, except for the
14	purpose of recleaning, they shall be labeled in accordance with this Chapter Part.
15	B. The provisions of R.S. 3:1444 shall not apply:

17	(2) To seeds in storage in, consigned to, or being transported to seed cleaning

21	(3) To agricultural seeds when grown, sold, and delivered by the producer
22	on his own premises when the growing of crops for reproductive purposes is not the
23	primary farming occupation of the producer. If the seeds are advertised for sale
24	through any medium or if the seeds are delivered by a common carrier, except for the
25	purpose of recleaning, they shall be labeled in accordance with this Chapter Part.

27	§1446. Penalty for violation; procedures for imposition of penalties
28	A. Whoever violates this Chapter Part or the rules and regulations made
29	under this Chapter Part shall may be subject to a civil penalty of not more than five
30	hundred dollars for each act of violation and for each day of violation. Each day on
