HOUSE RESOLUTION NO. 118

TEACHERS/EVALUATION: Requests the State Board of Elementary and Secondary Education to study issues relative to the implementation of the teacher evaluation program

A RESOLUTION

2	To urge and request the State Board of Elementary and Secondary Education to study issues
3	relative to the implementation of the state's teacher evaluation program and to report
4	its findings and recommendations, including any recommendations for legislation
5	relative to the issue, to the House Committee on Education prior to the beginning of
6	the 2014 Regular Session of the Legislature of Louisiana.
7	WHEREAS, beginning this year, teachers and other school employees are being
8	evaluated using the COMPASS evaluation rubric; and
9	WHEREAS, in developing COMPASS, the state Department of Education
10	collaborated with educators, parents, and state and local policymakers throughout the state;
11	and
12	WHEREAS, pursuant to COMPASS, teachers are given the following performance
13	ratings as a result of their evaluations-highly effective, effective: proficient, effective:
14	emerging, and ineffective; and
15	WHEREAS, fifty percent of each teacher's evaluation is based on student academic
16	achievement and the remaining half is based on observations by the teacher's principal or the
17	principal's designee; and
18	WHEREAS, over the course of the first year of implementation, changes were made
19	to COMPASS in response to concerns raised by many educators and policymakers; and

1	WHEREAS, these changes were made in order to make the program more effective
2	and to provide more clarity to teachers as to how the performance ratings are derived and
3	how they can use that information to grow; and
4	WHEREAS, as COMPASS continues to be a work in progress, further changes and
5	improvements may be necessary in order to ensure that the final product is the right one and
6	is the most reliable and effective tool for evaluating the performance of teachers and other
7	school employees.
8	THEREFORE, BE IT RESOLVED that the House of Representatives of the
9	Legislature of Louisiana does hereby urge and request the State Board of Elementary and
10	Secondary Education to study issues relative to the implementation of the state's teacher
11	evaluation program, including but not limited to the value-added model used and the ratings
12	given to teachers based on the evaluation results and to submit a written report of its findings
13	and recommendations, including any recommendations for legislation relative to the issue,
14	to the House Committee on Education not later than sixty days prior to the beginning of the
15	2014 Regular Session of the Legislature of Louisiana.
16	BE IT FURTHER RESOLVED that in conducting such study, the board shall
17	specifically consider and report on the following:
18	(1) Changing the requirement that fifty percent of the evaluation be based on student
19	academic achievement to instead require that it count for forty percent or other appropriate
20	lesser amount.
21	(2) Allowing a rating of ineffective to be offset by a rating of effective on certain
22	evaluation components.
23	(3) Discontinuing the use of percentiles in the value-added performance spectrum.
24	BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
25	president of the State Board of Elementary and Secondary Education and the state
26	superintendent of education.
