Provides for authorized agents for purposes of criminal history checks on nonlicensed persons and licensed ambulance

Purpose of Bill: To allow employees of background screening businesses to seek approval as an authorized agency to perform background checks. Currently, an individual must be a Louisiana licensed private investigator or detective. The bill would change that requirement to include employees of a background screening business as an alternative to being a Louisiana licensed private investigator or detective (these additional applicants would have to be domiciled in Louisiana).

EXPENDITURE EXPLANATION

There is no anticipated direct material effect on governmental expenditures as a result of this measure.

According to information received from the Department of Public Safety (DPS), this bill could increase the number of authorized agent applications received because it would allow background screening businesses, that were previously excluded, to submit an application to be an authorized agent. However, DPS does not estimate a large number of applications will be received due to the Louisiana domicile requirements in the bill. As amended, the proposed legislation may only have minimal related costs.

REVENUE EXPLANATION

There is no anticipated direct material effect on governmental revenues as a result of this measure.
