SCHOOLS/CHOICE: Requests that the State Bd. of Elementary and Secondary Education study issues relative to the implementation of the Course Choice Program and submit a report to the House and Senate education committees by Sept. 30, 2013

1	A CONCURRENT RESOLUTION
2	To urge and request the State Board of Elementary and Secondary Education to study issues
3	relative to the implementation of the Course Choice Program, including but not
4	limited to the enrollment of students by course providers and the approval of course
5	providers by the state board and to submit a report of its findings and conclusions,
6	including any recommendations for related legislation, to the House Committee on
7	Education and the Senate Committee on Education not later than September 30,
8	2013.
9	WHEREAS, as stated in the Constitution of Louisiana, it is the goal of the public
10	educational system to provide learning environments and experiences at all stages of human
11	development that are humane, just, and designed to promote excellence in order that every
12	individual may be afforded an equal opportunity to develop to his full potential; and
13	WHEREAS, current law provides for the Course Choice Program, through which
14	students may enroll in courses offered by a course provider; and
15	WHEREAS, current law defines a course provider as an entity that offers individual
16	courses in person or online, including but not limited to online or virtual education providers,
17	postsecondary education institutions, including any postsecondary institution under the
18	management of the Board of Supervisors of Community and Technical Colleges, and
19	corporations that offer vocational or technical course work in their field; current law also

1 requires that course providers be authorized by the State Board of Elementary and Secondary Education to provide such courses; and 2 3 WHEREAS, in an editorial by state superintendent of education John White, he states 4 that the Course Choice Program is "a first-of-its-kind initiative to provide every parent and 5 every student unprecedented access to educational courses provided beyond the walls of the 6 student's school"; and 7 WHEREAS, any time a new program is conceived and implemented, particularly one 8 which provides for the education of Louisiana's children "beyond the walls" of their schools, 9 every possible precaution must be taken to protect children's safety and to ensure their access 10 to a high quality education; and 11 WHEREAS, Superintendent White's editorial also states relative to the Course 12 Choice Program that "in every case, the parent and the student get to choose what's best for 13 them"; however, there are school system officials, principals, parents, and students who have 14 publicly expressed concern about a perceived lack of sufficient oversight relative to the 15 enrollment of students by some course providers; and 16 WHEREAS, a Course Choice Overview and Fact Sheet posted on the website of the 17 state Department of Education states that course providers must "pass an intensive four-step 18 selection process"; and 19 WHEREAS, there are already some safeguards in place, but because the safety and 20 education of Louisiana's children are of utmost importance, the processes by which course 21 providers enroll students and by which course providers are vetted by BESE prior to 22 approval merit a rigorous reexamination; and 23 WHEREAS, in order to fulfill the state's constitutional duty of affording every 24 student an equal opportunity to develop to his full potential, it is crucial that the 25 implementation of the Course Choice Program receive a thorough evaluation. 26 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby 27 urge and request the State Board of Elementary and Secondary Education to study issues 28 relative to the implementation of the Course Choice Program, including but not limited to

the enrollment of students by course providers and the approval of course providers by the

- 1 recommendations for related legislation, to the House Committee on Education and the
- 2 Senate Committee on Education not later than September 30, 2013.
- 3 BE IT FURTHER RESOLVED that a suitable copy of this Resolution be transmitted
- 4 to the president of the State Board of Elementary and Secondary Education and to the state
- 5 superintendent of education.
