HOUSE CONCURRENT RESOLUTION NO. 150

BY REPRESENTATIVES PYLANT AND GAROFALO

WATER/WELLS: Urges and requests the office of conservation to study, report, and make recommendations on the availability of qualified water well drillers, water well driller licensing requirements, and their impact on the rates charged for drilling water wells

A CONCURRENT RESOLUTION

2	To urge and request the Department of Natural Resources, office of conservation, in
3	consultation with the Water Resources Commission, to study, report, and make
4	recommendations on the availability of qualified water well drillers, water well
5	driller licensing requirements, and their impact on the rates charged for drilling of
6	water wells and to submit the report and recommendation to the House Committee
7	on Natural Resources and Environment and the Senate Committee on Natural
8	Resources on or before February 15, 2014.
9	WHEREAS, the water resources of the state are a precious natural resource necessary
10	for public health, safety, and economic well-being; and
11	WHEREAS, the water resources of the state and the United States, generally, are in
12	high demand and are in need of conservation and protection; and
13	WHEREAS, an important aspect of conservation and protection of our water
14	resources is ensuring that only qualified water well drillers install water wells, not only for
15	the sake of their customers, but also for the general public; and
16	WHEREAS, every person, firm, or corporation engaged, or desiring to engage in the
17	business of drilling water wells is by law required to be licensed; and
18	WHEREAS, despite the current demand for water well drillers, the decline in the
19	number of licensed water well drillers has outpaced new drillers; and

1 WHEREAS, the demand for water wells, especially for shallow wells less than two 2 hundred feet for agricultural use, has increased; and 3 WHEREAS, the decrease in the availability of licensed water well drillers and its 4 potential impact on the rates charged have led land owners to seek options to install water 5 wells themselves on their own land for agricultural use; and 6 WHEREAS, Act No. 437 of the 2009 Regular Session of the Legislature transferred, 7 along with other responsibilities ground water resource management, the administration of the laws, rules, and regulations providing for the licensing of water well drillers from the 8 9 Department of Transportation and Development to the Department of Natural Resources, 10 office of conservation; and 11 WHEREAS, the House Committee on Natural Resources and Environment 12 considered House Bill No. 208 with great discussion on several issues, including the demand 13 of, the qualifications for, the two-year apprentice requirement for, and the testing 14 requirements for licensing water well drillers, and the role of the advisory committee, 15 created by R.S. 38:3098.6. 16 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby 17 urge and request the Department of Natural Resources, office of conservation, in 18 consultation with the Water Resources Commission, to study and report a detailed review 19 of the availability and demand for qualified water well drillers, the demand for shallow water 20 wells less than two hundred feet for agricultural use, the rules and regulations regarding the 21 licensing of water well drillers, including but not limited to qualifications, the two-year 22 apprentice requirement, and the testing of water well drillers, as well as the role of the 23 advisory committee created by R.S. 38:3098.6, in ensuring that only qualified water well 24 drillers are licensed to the House Committee on Natural Resources and the Environment and 25 the Senate Committee on Natural Resources by February 15, 2014. 26 BE IT FURTHER RESOLVED that the Legislature of Louisiana does hereby urge 27 and request the Department of Natural Resources, office of conservation, in consultation 28 with the Water Resources Commission, to propose recommendations to address the concerns 29 of the availability of qualified water well drillers and its impact on the rates charged, 30 changes, if any, to the rules and regulations on the licensing of qualified water well drillers,

- 1 including but not limited to changes to qualifications, the two-year apprentice requirement,
- 2 and the testing of prospective water well drillers, to ensure that the state's precious natural
- 3 water resources are protected for public health, safety, and economic well-being, and report
- 4 any such recommendations to the House Committee on Natural Resources and Environment
- 5 and the Senate Committee on Natural Resources by February 15, 2014.
- 6 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
- 7 Department of Natural Resources, commissioner of conservation.
