Prefiled pursuant to Article III, Section 2(A)(4)(b)(i) of the Constitution of Louisiana.

1	AN ACT
2	To authorize and provide for the transfer of certain state property; to authorize the transfer
3	of certain state property in Rapides Parish; to provide for the property descriptions;
4	to provide for reservation of mineral rights; to provide terms and conditions; to
5	provide an effective date; and to provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. The secretary of the Department of Health and Hospitals, notwithstanding
8	any other provision of law to the contrary, is hereby authorized and empowered to convey,
9	transfer, assign, lease or deliver any interest, excluding mineral rights, the state may have
10	to all or any portion of the following described parcels of property to the city of Pineville:
11 12 13 14 15 16 17 18 19	A certain piece, parcel or lot of ground, together with all improvements thereon, rights, ways and privileges thereunto belonging or in any way appertaining, being, lying and situated in the Section 17, Township 4 North, Range 1 West, Rapides Parish, Louisiana, being more particularly described as follows, to wit: Commencing at a 4" x 4" concrete monument marking the northwest corner of the city of Pineville's Wastewater Treatment Facility tract; thence proceed South 39 degrees 05 minutes 29 seconds West, grid bearing, along the northwest boundary line of said city of Pineville tract, a distance of 371.23 feet to a 5/8" diameter iron rod (set) marking the POINT OF BEGINNING of the tract be described;
20 21 22 23 24 25 26 27 28 29 30 31 32 33	thence continue South 39 degrees 05 minutes 29 seconds West, along said northwest boundary line, a distance of 693.37 feet to a 3/4" diameter iron rod (found) marking the southwest corner of said city of Pineville Wastewater Treatment Facility tract; thence continue South 39 degrees 05 minutes 29 seconds West, along an extension of said northwest boundary line and crossing the Red River Levee, a distance of 275.82 feet to a 5/8" diameter iron rod (set); thence turn right and proceed North 38 degrees 30 minutes 43 seconds West, departing said northwest boundary line extension, a distance of 88.36 feet to a pk nail with shiner in asphalt pavement (set); thence turn right and proceed North 10 degrees 22 minutes 23 seconds West, a distance of 226.13 feet to a 5/8" diameter iron rod (set); thence turn right and proceed South 86 degrees 46 minutes 58 seconds East, a distance of 465.08 feet to a 5/8" diameter iron rod (set); thence turn right and proceed South 24 degrees 18 minutes 32 seconds East, a distance of 465.00 feet to the POINT OF BEGINNING;

The above described tract contains 12.299 acres, more or less, and is more particularly
indicated as Tract 1 on Pan American Engineers - Alexandria, Inc., Drawing No. 12089,
dated November 2, 2012.

1 Section 2. The secretary of the Department of Health and Hospitals is hereby 2 authorized to enter into such agreements, covenants, conditions, and stipulations and to 3 execute such documents as necessary to properly effectuate any conveyance, transfer, 4 assignment, lease or delivery of title, excluding mineral rights, to the property described in 5 Section 1 of this Act, and as more specifically described in any such agreements entered into 6 and documents executed by and between the secretary of the Department of Health and 7 Hospitals and the city of Pineville, in exchange of consideration proportionate to the 8 appraised value of the property.

- 9 Section 3. The secretary of the Department of Culture, Recreation and Tourism,
- 10 notwithstanding any other provision of law to the contrary, is hereby authorized and
- 11 empowered to convey, transfer, assign, lease or deliver any interest, excluding mineral
- 12 rights, the state may have to all or any portion of the following described parcel of property
- 13 to the city of Pineville:
- A certain piece, parcel or lot of ground, together with all improvements thereon, rights, ways
 and privileges thereunto belonging or in any way appertaining, being, lying and situated in
 the Section 17, Township 4 North, Range 1 West, Rapides Parish, Louisiana, being more
 particularly described as follows, to wit:
- Commencing at a 4" x 4" concrete monument marking the northwest corner of the city of
 Pineville's Wastewater Treatment Facility tract; thence proceed South 39 degrees 05 minutes
 29 seconds West, grid bearing, along the northwest boundary line of said city of Pineville
 tract, a distance of 204.78 feet to a 5/8" diameter iron rod (set) marking the POINT OF
 BEGINNING of the tract be described;
- thence continue South 39 degrees 05 minutes 29 seconds West, along said northwest
 boundary line, a distance of 166.45 feet to a 5/8" diameter iron rod (set); thence turn right
 and proceed North 24 degrees 18 minutes 32 seconds West, departing said northwest
 boundary line, a distance of 133.37 feet to a 5/8" diameter iron rod (set); thence turn right
 and proceed North 87 degrees 15 minutes 46 seconds East, a distance of 160.05 feet to the
 POINT OF BEGINNING;
- The above described tract contains 0.228 acres, more or less, and is more particularly
 indicated as Tract 2 on Pan American Engineers Alexandria, Inc., Drawing No. 12089,
 dated November 2, 2012.
- 32 Section 4. The secretary of the Department of Culture, Recreation and Tourism is
- hereby authorized to enter into such agreements, covenants, conditions, and stipulations and
- 34 to execute such documents as necessary to properly effectuate any conveyance, transfer,
- 35 assignment, lease or delivery of title, excluding mineral rights, to the properties described
- in Section 3, and as more specifically described in any such agreements entered into and
- documents executed by and between the secretary of the Department of Culture, Recreation

and Tourism and the city of Pineville, in exchange of consideration proportionate to the appraised value of the property.

Section 5. This Act shall become effective upon signature by the governor or, if not
signed by the governor, upon expiration of the time for bills to become law without signature
by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
vetoed by the governor and subsequently approved by the legislature, this Act shall become
effective on the day following such approval.
