6 6007.1" and insert "and (D)(9)"

7 AMENDMENT NO. 3

8 On page 2, line 7, after "**audit shall**" delete the remainder of the line, delete line 8 in its
9 entirety, and from the beginning of line 9, delete "**47:6007.1 and shall**"

10 AMENDMENT NO. 4

11 On page 4, line 4, after "submit to the" delete the remainder of the line

12 AMENDMENT NO. 5

13 On page 4, line 6, after "within" and before "days" delete "**seven**" and insert "**ten**"

15 On page 4, line 21, after "to the" and before "shall" delete "office" and insert "**Department**
16 **of Revenue**"

17 AMENDMENT NO. 7

18 On page 4, line 22, after "and any" delete "pricing"

2 On page 5, line 17, after "**for all**" delete the remainder of the line, delete lines 18 through
3 21 in their entirety, and insert the following:

4 **"qualifying expenditures verified by the office. Any expenditures for which tax**
5 **credits were neither denied nor certified due to insufficient information or other**
6 **issues, the office and secretary shall diligently work to resolve the outstanding**
7 **issues in a timely manner, and the office and secretary may subsequently issue**
8 **a supplemental tax credit certification at the time of such resolution."**

12 AMENDMENT NO. 12

13 On page 6, line 19, after "**rules**" delete the comma " ," and insert "**regarding related party**

15 AMENDMENT NO. 13

16 On page 6, line 20, after "**Act**" delete the remainder of the line, delete lines 21 through 29
17 in their entirety, delete pages 7 through 11 in their entirety, and insert a period " ."
