1 AMENDMENT NO. 1

2 On page 1, delete line 5 and insert the following:

3 "purposes; to provide for effective dates; and to provide"

4 AMENDMENT NO. 2

5 On page 8, delete lines 27 through 31, insert the following:

6 "Section 4. The appropriations and allocations contained in this Section shall be in  
7 addition to and supplemental to all of the appropriations made in the Act which originated  
8 as House Bill No. 1 of the 2013 Regular Session of the Legislature, and the appropriations  
9 and allocations made in this Section shall be deemed to be incorporated into, made a part of,  
10 and expended in accordance with and in all respects shall be subject to all of the conditions,  
11 stipulations, and provisions of Sections 1 through 18 of the Act which originated as House  
12 Bill No. 1 of the 2013 Regular Session of the Legislature. In accordance with the provisions  
13 of R.S. 39:57.1, the commissioner of administration shall notify each budget unit receiving  
14 an allocation or appropriation in this Section as to the nature and amount of allocation or  
15 appropriation contained herein no later than two weeks after the effective date of this Act.

18 **09-306 MEDICAL VENDOR PAYMENTS**

19 The commissioner of administration is hereby authorized and directed to transfer the  
20 amounts necessary to the Louisiana State University Health Sciences Center - Shreveport,  
21 Huey P. Long Medical Center, and E.A. Conway Medical Center to provide funding at such  
22 hospitals in amount equal to or greater than the amount provided to such hospitals in Fiscal  
23 Year 2011-2012 plus any amount necessary for termination pay.

24 Section 5. Section 4 of this Act shall become effective on July 1, 2013; if vetoed by  
25 the governor and subsequently approved by the legislature, Section 4 of this Act shall  
26 become effective on July 1, 2013, or on the day following such approval by the legislature,  
27 whichever is later.

28 Section 6. Sections 1, 2, 3, 5, and 6 of this Act shall become effective upon signature  
29 of this Act by the governor or, if not signed by the governor, upon expiration of the time for  
30 bills to become law without signature by the governor, as provided by Article III, Section  
31 18 of the Constitution of Louisiana. If this Act is vetoed by the governor and subsequently  
32 approved by the legislature, Sections 1, 2, 3, 5, and 6 of this Act shall become effective on  
33 the day following such approval."
