Authorizes imposition of court cost in Orleans Parish Criminal District Court under certain circumstances to defray operating expenses of clerk. (2/3 - CA7s2.1) (gov sig)

**Purpose of Bill:** This bill provides relative to the funding of the Clerk of Orleans Parish Criminal District Court (Clerk) by the City of New Orleans (City), including requiring legislative approval for the City to reduce funding to the Clerk. The bill also provides for the authority of the City as it relates to constitutional, state, and district officers and their employees/subordinates.

The provisions of this bill will become effective on July 1, 2013.
