2	To amend and reenact R.S. 27:415 and 422(D)(1), relative to Video Draw Poker Devices
3	Control Law; to provide for the location of certain video draw poker facilities; to
4	provide for prohibited distances of certain video draw poker facilities; and to provide
5	for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 27:415 and 422(D)(1) are hereby amended and reenacted to read as
8	follows:
9	§415. Pari-mutuel wagering facility or offtrack wagering facility; no minimum
10	wager <u>;</u> <u>location</u>
11	A. A person owning a Louisiana State Racing Commission licensed pari-
12	mutuel wagering facility or an offtrack wagering facility may be granted a license
13	for the placement of video draw poker devices in his facility if all other requirements
14	of this Chapter are met. There shall be no limit on the number of video draw poker
15	devices which may be placed at the facility. Notwithstanding any provision of law
16	to the contrary, video draw poker devices in these facilities may schedule games with
17	no minimum wager.
18	B. Notwithstanding the provisions of R.S. 4:214(A)(4), no more than five
19	Louisiana State Racing Commission licensed pari-mutuel facilities or offtrack
20	wagering facilities that operate video draw poker devices shall be located within
21	Jefferson Parish.

23	§422. Truck stop locations; prohibited distances; prohibited structures

SB NO. 164 ENROLLED D.(1) For locations on which a truck stop facility has not been completely constructed, if application for licensing is was made on or before August 1, 2012, the prohibited distance shall be in accordance with the following: (a) For facilities which applied for or were issued a certificate of compliance or a valid building permit on or before January 1, 2008 - five hundred feet from any property on the National Register of Historic Places, any public playground, or a building used primarily as a church, synagogue, public library, or school. (b) For facilities which applied for or were issued a certificate of compliance or a valid building permit after January 1, 2008, but on or before June 1, 2010 - two thousand five hundred feet from any property on the National Register of Historic Places, any public playground, or a building used primarily as a church, synagogue, public library, or school. (c) For facilities which applied for or were issued a certificate of compliance or a building permit after June 1, 2010 - one mile from any property on the National Register of Historic Places, any public playground, residential property, or a building used primarily as a church, synagogue, public library, or school.
