 Provides relative to certain annual license fee renewals for participating in horse racing. (7/1/13)

Current law provides for a 3-year license for owners, trainers, jockeys, jockey agents, exercise persons, veterinarians and colors registration. Current law retains present law but authorizes renewal of the annual license fee for up to a 3-year period which expires June 30th of the 3rd year in place of a 3-year license. Effective July 1, 2013.

EXPENDITURE EXPLANATION

There is no anticipated direct material effect on governmental expenditures as a result of this measure.

REVENUE EXPLANATION

The proposed legislation will result in a nominal decrease in self-generated revenues to the LA State Racing Commission. According to the Racing Commission, the 1-year registration fee for exercise persons, jockeys and jockey agents was previously changed in R.S. 4:169 (A), while the corresponding 3-year registration fee in R.S. 4:169(B) was mistakenly not amended to reflect the fee change for the 1-year license.

The 3-year registration fee currently charged by the LA Racing Commission is the 1-year fee multiplied by 3. Current law does not provide for this in R.S. 4:169(B). This bill seeks to correct this issue. See Table Below:

Based upon current statutes and the actual number of 3-year licenses sold in FY 12 for jockeys/jockey agents and exercise persons, the proposed legislation will result in a decrease in self-generated revenues to the Louisiana Racing Commission in the amount of \$420 annually.
