HOUSE RESOLUTION NO. 184

GOVERNMENT ORGANIZATION: Requests the House Committee on House and Governmental Affairs to study and make recommendations relative to the organization of the executive branch of state government

A RESOLUTION

2	To authorize and request the House Committee on House and Governmental Affairs to
3	conduct further study of the organization of the executive branch of state government
4	and to report its findings and recommendations to the House of Representatives of
5	the Legislature of Louisiana prior to the convening of the 2014 Regular Session of
6	the Legislature of Louisiana.
7	WHEREAS, House Study Request No. 9 of the 2012 Regular Session requested the
8	House Committee on House and Governmental Affairs to study the organization of the
9	executive branch of state government and to report its findings and recommendations to the
10	House of Representatives; and
11	WHEREAS, pursuant to the study request, the chairman of the House Committee on
12	House and Governmental Affairs requested detailed written information from officials of
13	executive branch departments and agencies to assist the committee in performing its study;
14	and
15	WHEREAS, the committee held a number of extensive hearings to discuss the
16	information received with representatives of the departments and to explore possible
17	recommendations for legislation; and
18	WHEREAS, the study revealed a number of areas that warrant further consideration
19	and study.

1	THEREFORE, BE IT RESOLVED that the House of Representatives of the
2	Legislature of Louisiana does hereby authorize and request the House Committee on House
3	and Governmental Affairs to conduct further study of the organization of the executive
4	branch of state government and to report its findings and recommendations to the House of
5	Representatives prior to the convening of the 2014 Regular Session of the Legislature of
6	Louisiana.
7	BE IT FURTHER RESOLVED that the study shall include, without limitation,
8	examination of the following:
9	(1) The advisability of expanding the authority of the division of administrative law
10	to cover agencies currently exempted from having adjudications conducted by the division
11	and agencies whose adjudications are currently only partially being conducted by the
12	division.
13	(2) The advisability of the office of mineral resources and the Mineral and Energy
14	Board in the Department of Natural Resources administering and managing mineral leases
15	for all state departments, agencies, and institutions.
16	(3) The advisability of the charitable gaming and alcoholic beverage control
17	functions of the Department of Revenue being transferred to public safety services of the
18	Department of Public Safety and Corrections.
19	(4) The advisability of transferring the state's audit functions relative to
20	unemployment insurance taxes to the Department of Revenue.
21	(5) The respective functions and capabilities of the State Police Commission and the
22	Department of State Civil Service to determine which functions could be consolidated and
23	how resources and personnel could best be utilized, particularly as related to testing
24	functions and office of management and finance functions.
25	(6) The consolidation of reporting of extracted mineral resources, royalty payments,
26	and severance taxes.
27	(7) The consolidation of reporting of unemployment and withholding taxes.
28	(8) The authority and functions of the state treasurer provided by law, particularly
29	R.S. 36:801.3, relative to the four state retirement systems in the Department of the
30	Treasury.
