| 14 | D. The council, with appropriate consultation and collaboration with the |

| 18 | industry-based certification courses as provided in R.S. 17:3165.1. |

| 14 | (a) The content of each academic transfer module may be contained in |

| 16 | (b) Each academic transfer module shall be equal to at least one college |
| 17 | credit hour and modules can be combined to become the academic equivalent |
| 18 | of a complete academic college course. |
| 19 | (2) Align the content contained in each academic transfer module with |

| 21 | academic college course to which the module will be applied. |
