2	To enact R.S. 17:2115.11, relative to student prayer gatherings; to permit student prayer	
3	gatherings; to provide conditions; and to provide for related matters.	
4	Be it enacted by the Legislature of Louisiana:	
5	Section 1. R.S. 17:2115.11 is hereby enacted to read as follows:	
6	<u>§2115.11. Prayer; student-initiated; conditions</u>	
7	A. Upon the request of any public school student or students, the proper	
8	school authorities may permit students to gather for prayer in a classroom,	
9	auditorium, or other space that is not in use, at any time before the school day begins	
10	when the school is open and students are allowed on campus, at any time after the	
11	school day ends provided that at least one student club or organization is meeting at	
12	that time, or at any noninstructional time during the school day. A school employee	
13	may be assigned to supervise the gathering if such supervision is also requested by	
14	the student or students and the school employee volunteers to supervise the	
15	gathering.

3	C. Any parent may attend the gather	ing if the parent adheres to school

6	participate in the gathering if other school org	anizations and clubs are allowed to
7	make similar invitations. Such persons shal	ll adhere to school procedures for
8	approval of visitors on the school campus.
