1	AN ACT
2	To enact R.S. 17:10.3, relative to school and district accountability; to provide that a student
3	with an exceptionality, other than gifted and talented, who is not pursuing a regular
4	diploma shall not be administered certain tests; to provide for exceptions; to provide
5	that such lack of test participation shall not be considered in the calculation of school
6	and district performance scores or letter grades; and to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 17:10.3 is hereby enacted to read as follows:
9	§10.3. School and district accountability; prohibited testing; exceptions
10	A. A student with an exceptionality as defined in R.S. 17:1942(B), but
11	is not deemed gifted and talented, who is not pursuing a regular diploma shall
12	not be administered any test pursuant to R.S. 17:24.4 or the state's school and
13	district accountability system, including the American College Test, unless the
14	student's parent or other legal guardian requests, in writing, that the student
15	be administered the test or the student's Individualized Education Plan
16	indicates that the test is an appropriate assessment instrument for the student.
17	<b>B.(1)</b> The nonparticipation of a student with an exceptionality as
18	provided in Subsection A of this Section in the administration of any test shall
19	not, in any manner, be factored into the calculation of any performance score
20	or performance letter grade assigned to any school or school system in which
21	the student is enrolled, provided that such exclusion does not violate any federal
22	law or requirement, including the No Child Left Behind Act of 2001 or the
23	Individuals with Disabilities Education Act.

#### **ENROLLED**

1	(2) A student who is not administered a test pursuant to this Section
2	shall not be penalized for failure to take the test. For purposes of this
3	Subsection, prohibited penalties include but are not limited to:
4	(a) Withholding of credits toward graduation or denying a
5	student the ability to graduate.
6	(b) Denying a student the opportunity to participate in an
7	extracurricular activity.
8	(c) Denying a student the ability to advance to the subsequent
9	grade level.
10	Section 2. This Act shall become effective upon signature by the governor or, if not
11	signed by the governor, upon expiration of the time for bills to become law without signature
12	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
13	vetoed by the governor and subsequently approved by the legislature, this Act shall become
