2 parish library to provide the same high-quality programs for summer reading at each of the  
3 six library locations throughout the parish; and

5 compassion who represents all that is good about Louisiana and whose goodness of heart has  
6 touched the lives of countless individuals; and

7           WHEREAS, Susy Lemoine merits a sincere and heartfelt measure of commendation
