## Martiny (SB 139)

Present law provides for definitions.

<u>Proposed law</u> retains <u>present law</u> and adds the definition of "watercraft" to mean any contrivance used or designated for navigation on water, including but not limited to a personal watercraft as defined by law.

Present law provides for the establishment of a new marine dealership.

<u>Proposed law</u> exempts from <u>present law</u> marine products consisting of trolling motors or boat or watercraft trailers.

<u>Present law</u> provides that it is a violation of law for a manufacturer, a distributor, a wholesaler, distributor branch, or factory branch of marine products or any officer, agent,
