Repeals the Louisiana Systemic Initiatives Program (LaSIP).(gov sig)

The proposed legislation would repeal the Louisiana Systemic Initiatives Program (LaSip). LaSIP is aimed at improving math and science education in agreement with the National Science Foundation by addressing a number of areas including but not limited to: teacher preparation and certification, professional development, curricula materials and assessments, and community partnerships. The 26 member LaSIP Council approves sponsored activities, projects and programs and awards competitive grants to participating universities. The program is funded with grants from the National Science Foundation (NSF) and matching state funds.

EXPENDITURE EXPLANATION

There is no anticipated direct material effect on governmental expenditures as a result of this measure.

The last federal award from the NSF totaling \$7 M occurred in FY 97 for the five year period FY 97 through FY 01. The Board of Regents (BOR) and the Board of Elementary and Secondary Education (BESE) each contributed \$5 M in matching funds. In 2008 LaSIP successfully applied for and received a second Gaining Early Awareness and Readiness for Undergraduate Programs (GEAR UP) grant of \$18 M over 6 years. State match consisted of in-kind contributions and no funds were utilized to meet the match requirements through June 2014. State general fund support for the administration and operations of the program ended in 2010 and all LaSIP personnel were terminated. At that time the GEAR UP grant and associated personnel were transferred to the Office of Student Financial Assistance (OSFA) The last LaSIP Council meeting was held on March 23, 2012.

NOTE: The LaSIP name continues to be used as a reference when issuing RFP's to fund projects focused on K-12 teacher professional development initiatives through No Child Left Behind (NCLB) grants.

REVENUE EXPLANATION

There is no anticipated direct material effect on governmental revenues as a result of this measure.
