HOUSE BILL NO. 1043

APPROPRIATIONS/JUDGMENT: Appropriates funds for payment of judgment against DOTD in the matter of "Artimese Duplechain v. City of Opelousas, et al"

1 AN ACT

2 To appropriate funds out of the General Fund of the state of Louisiana for Fiscal Year 2014-
3 2015 to be used to pay the consent judgment against the Department of
4 Transportation and Development in the suit entitled "Artimese Duplechain v. City
5 of Opelousas, et al"; and to provide for related matters.

6 Be it enacted by the Legislature of Louisiana:

7 Section 1. The sum of Five Thousand and No/100 (\$5,000.00) Dollars is hereby
8 appropriated out of the General Fund of the state of Louisiana for Fiscal Year 2014-2015 to
9 be used to pay the consent judgment against the Department of Transportation and
10 Development in the suit entitled "Artimese Duplechain v. City of Opelousas, et al", bearing
11 Number 11-C-3075-B on the docket of the Twenty-Seventh Judicial District Court, parish
12 of St. Landry, state of Louisiana.

13 Section 2. The sum of Five Hundred Eighty-Three and 94/100 (\$583.94) Dollars is
14 hereby appropriated out of the General Fund of the state of Louisiana for Fiscal Year 2014-
15 2015 to be paid to the Department of Health and Hospitals for Medicaid reimbursement in
16 the suit against the Department of Transportation and Development entitled "Artimese
17 Duplechain v. City of Opelousas, et al", bearing Number 11-C-3075-B on the docket of the
18 Twenty-Seventh Judicial District Court, parish of St. Landry, state of Louisiana.

1 Section 3. This Act shall become effective on July 1, 2014; if vetoed by the governor
2 and subsequently approved by the legislature, this Act shall become effective on July 1,
3 2014, or on the day following such approval by the legislature, whichever is later.
