HEALTH/HOSPITALS DEPT. Urges the Department of Health and Hospitals to study the feasibility, desirability, and practicality of alternative transportation sites (i.e. urgent care clinics) for certain patients.

2	To urge and request the Department of Health and Hospitals to study the feasibility,
3	desirability, and practicality of alternative transportation sites (i.e. urgent care
4	clinics) for patients who access emergency medical services via the 911 system and
5	the use of ambulance service providers and suppliers to assist with training and
6	management of this population.
7	WHEREAS, the University of California, Davis, Institute for Population Health
8	Improvement indicates the expansion of a community paramedicine program using the assets
9	and resources of the ambulance service industry ensures that expensive emergency care
10	resources are optimally utilized; and
11	WHEREAS, the Centers for Medicare and Medicaid Innovation commissioned a
12	study with an ambulance group in Reno, Nevada, in 2012 to explore transporting patients
13	who do not present an emergent condition at the time of transport to an alternative
14	destination site rather than an emergency room involving reimbursement through the
15	Medicare program; and
16	WHEREAS, several published studies by ambulance services in Texas, Minnesota
17	and Pennsylvania indicate that the use of paramedics as mobile healthcare practitioners to
18	manage and redirect nonemergency 911 usage has resulted in significant savings for

1 taxbased entities.
