2	To amend and reenact R.S. $56:327(A)(2)$ and $412(A)(4)$ and (6) and to repeal R.S. $56:327.1$,
3	relative to the importation of certain fish; to provide for importation regulations and
4	licensing requirements; to provide certain size requirements for importation; to
5	exempt certain persons from the notification provisions; to remove certain provisions
6	relative to the importation of aquaculturally raised fish and cultured fish; to provide
7	terms, conditions, and requirements; and to provide for related matters.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. R.S. 56:327(A)(2) and 412(A)(4) and (6) are hereby amended and
10	reenacted to read as follows:
11	§327. Sale or purchase of freshwater or saltwater game fish prohibited; commercial

Red drum, hybrid striped bass, or any other game fish 2 species approved by the commission, which are legally taken, possessed, or sold commercially outside of the state, and aquaculturally raised game fish, may be 3 imported, sold, or purchased by properly licensed wholesale/retail seafood dealers 4 5 persons. Except those game fish being imported under a domesticated aquatic organisms license, prior Prior to each shipment into this state of any game fish for 6 7 consumption, the buyer or handler of such shipment shall notify the secretary or his 8 designated agent of its pending arrival and shall possess a bill of lading therefor. The 9 bill of lading shall state the species of fish contained in each shipment, the number 10 of fish or parts thereof, the origin of the shipment, the destination of the shipment, 11 the consignee and consignor, and where applicable, the grower's name and fish 12 farmer's license number. Wholesalers, their agents, and commercial transporters 13 delivering the shipment or portions thereof to retail dealers shall provide each dealer with a copy of their bill of lading and shall indicate thereon the date of delivery to 14 the retailer, the species of fish delivered, and the number of fish or parts thereof 15 delivered. Both wholesale and retail dealers shall maintain a file of such bills of 16 lading which shall be open to inspection by the secretary, his agents, or any 17 enforcement agents. Regulations adopted by the commission may utilize a 18 19 confirmation number system in lieu of copies of bills of lading provided by wholesale/retail seafood dealers to retail seafood dealers. 20 21 22 §412. DIGEST

<u>Present law</u> requires the commission to promulgate rules and regulations for the importation, possession, or sale of game fish species. Allows licensed wholesale/retail dealers to import, sell, or purchase aquaculturally raised game fish.

<u>Proposed law</u> allows any properly licensed person to import, sell, or purchase aquaculturally raised game fish.

<u>Present law</u> requires that the buyer or handler of each shipment of any game fish notify the secretary before its impending arrival.

<u>Proposed law</u> provides an exception to the notification requirement for any game fish being imported under the domesticated aquatic organisms license.

<u>Present law</u> allows persons engaged in the business of aquaculture to sell domesticated aquatic organisms in any size, quantity, or limit without restriction within the state or outside of the state and exempts these persons from certain wholesale/retail seafood license requirements.

<u>Proposed law</u> exempts persons engaged in the business of aquaculture from certain notification provisions.

Present law provides size requirements for the importation of certain fish species.

<u>Proposed law</u> increases the maximum size limit for rock bass, white bass, yellow bass, crappie, and bream fingerlings <u>from</u> three to six inches and removes the maximum size limit for spotted or striped bass.

Proposed law repeals present law.

Effective August 1, 2014.
