FISCAL CONTROLS Provides that certain audits completed by the office of the legislative auditor shall be reported to the Joint Legislative Committee on the Budget on an annual basis. (7/1/14)

Proposed legislation provides for the legislative auditor to annually file copies of certain audit reports released by his office with the Joint Legislative Committee on the Budget (JLCB) that have a dollar impact of \$150,000 or more relative to the following: waste or inefficiencies in government, missed revenue collections, improper payments or overpayments by the state, theft of money, failing to meet funding obligations such as pension or health benefits, failure to comply with federal grant requirements, failure to comply with state funding requirements, misappropriation of funds, errors in or insufficient support for disaster expenditures, accountability of public money associated with various disasters such as the Deepwater Horizon event. Proposed legislation provides that such reports be submitted quarterly to the JLCB. Effective July 1, 2014.
