Increases authorized court costs for municipal ordinance violations in the mayor's court in the town of Anacoco. (8/1/14)

Purpose of Bill: This measure authorizes the Mayor of the Town of Anacoco to impose an additional court cost for municipal ordinance violations not to exceed \$20 for each offense.
