Provides relative to motions for summary judgments. (8/1/14)

Proposed law provides that the movant in a motion for summary judgment shall file with his motion and memorandum a list of the exhibits he intends to offer, file, and introduce into evidence at the hearing, which shall be served within the time limits provided in District Court Rule 9.9. Further provides that no other exhibits shall be considered by the court at the hearing on the motion for summary judgment. Proposed law provides that all service requirements shall be made in accordance with present law. Further provides that all parties shall be allowed adequate discovery which shall be conducted within a reasonable period of time. Proposed law provides that any objections to any listed exhibits shall be made by a motion to strike filed not later than three days prior to the hearing on the motion for summary judgment. Further provides any objections by any party shall be heard and decided by the court prior to the hearing on the motion for summary judgment.
