2	To amend and reenact R.S. 56:1948.5(50), to enact R.S. 56:1948.5(65), and to repeal R.S.
3	56:1948.5(20), (48), (51), and (54), relative to Louisiana Byways; to designate
4	sections of certain highways as Louisiana Byways; and to provide for related
5	matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 56:1948.5(50) is hereby amended and reenacted and R.S.
8	56:1948.5(65) is hereby enacted to read as follows:
9	§1948.5. Louisiana Byways designations
10	The following highways and sections of highways are hereby designated as
11	Louisiana Byways:

13	(50) Louisiana's Bayou Teche Scenic Byways:
14	(a) LA 182 from Iberia Parish Line to Adeline its intersection with 6th Street
15	in Morgan City northwest to its intersection with US 90, including its routing
16	through Morgan City, Berwick, Bayou Vista, and Patterson in St. Mary Parish.
17	(b) LA 326 from Adeline to Baldwin US 90 from its intersection with LA
18	182 west to its intersection with LA 182 in St. Mary Parish.
19	(c) LA 182 from Baldwin to Calumet its intersection with US 90 west to its
20	intersection with LA 31, including its routing through Franklin, Baldwin, Jeanerette,
21	and New Iberia in St. Mary and Iberia parishes

17	1 from its intersection with LA 31 east to its intersection with LA 328 in Breaux

13	municipal boundary of Delcambre located in Iberia Parish.
14	Section 2. R.S. 56:1948.5(20), (48), (51), and (54) are hereby repealed in their
15	entirety.

Guinn HB No. 1055

Abstract: Amends provisions designating certain highways as La. Byways.

Present law designates certain sections of highways as La. Byways.

<u>Proposed law</u> designates certain highways in Vermilion and Iberia parishes as official routes of a La. Byway known as the Cajun Corridor Byway.

Proposed law amends the route of La.'s Bayou Teche Scenic Byway.

Proposed law removes the designation of the Jean Lafitte Scenic Byway, La.'s Promised Land Bayou/Basin Route to Our Cultural Roots, Iberia Parish Bayou Browsing Scenic Byways, and Jean Lafitte Scenic Byways as La. Byways.
