1 AMENDMENT NO. 1

2 On page 1, at the beginning of line 6 after "images" insert "and wireless data"

3 AMENDMENT NO. 2

4 On page 1, line 11, after "**images**" insert "**and wireless data**"

5 AMENDMENT NO. 3

6 On page 2, between lines 1 and 2, insert the following:

7 **"(2) Use an unmanned aircraft to capture a wireless data transmission**  
8 **for any purpose not authorized by the sender or recipient of the wireless data**  
9 **transmission."**

10 AMENDMENT NO. 4

11 On page 2, at the beginning of line 2, change "**(2)**" to "**(3)**"

12 AMENDMENT NO. 5

13 On page 2, at the beginning of line 4, change "**(3)**" to "**(4)**"

14 AMENDMENT NO. 6

15 On page 2, between lines 16 and 17, insert the following:

16 **"(3) "Wireless data transmission" or "data" means any transmission of**  
17 **digital information or any communication via a wireless Internet service,**  
18 **cellular telephone, or similar device or means of transmission."**

20 On page 2, line 17, after "**violation of**" insert "**Paragraph (B)(1) of**"

25 On page 4, line 18, after "**facilities**" delete the remainder of the line and insert a period "."

27 AMENDMENT NO. 10

28 On page 4, between lines 23 and 24, insert the following:

29 **"(17) As authorized or permitted by the Federal Aviation Administration**  
30 **for use in a motion picture, television, or similar production when the**  
31 **production is authorized by the property owner and authorized by a state or**

1 local permit agency, if authorization for the production by a state or local  
2 permit agency is required.

3 F. It shall not be a violation of Paragraph (B)(2) of this Section to capture  
4 a wireless data transmission using an unmanned aircraft:

5 (1) In airspace designated as a test site or range authorized by the  
6 Federal Aviation Administration for the purpose of integrating unmanned  
7 aircraft systems into the national airspace.

8 (2) As part of an operation, exercise, or mission of any branch of the  
9 United States military.

10 (3) Pursuant to a valid search or arrest warrant."
