Abstract: Provides relative to the membership of the Nursing Supply and Demand Council.

<u>Present law</u> establishes the Nursing Supply and Demand Council as an advisory council to the Louisiana Health Works Commission and provides for the membership of the council.

<u>Proposed law</u> corrects the name of the Association of periOperative Registered Nurses to the Louisiana Council of periOperative Registered Nurses Chapters.

<u>Proposed law</u> deletes references to the following defunct organizations from the listing of entities comprising the membership of the Nursing Supply and Demand Council:

- (1) The La. Alliance of Nursing Organizations.
- (2) The La. Practical Nurses Association.

(Amends R.S. 37:1007(A)(2)(a)(xvi); Repeals R.S. 37:1007(A)(2)(a)(xi) and (xiv))
