SENATE CONCURRENT RESOLUTION NO. 87

BY SENATOR MILLS

HEALTH CARE. Directs DHH to create a working group to study the future of state health care funding.

1	A CONCURRENT RESOLUTION
2	To authorize and direct the Department of Health and Hospitals to create a working group
3	to study the future of health care funding in Louisiana.
4	WHEREAS, disproportionate share dollars from the federal government will be
5	decreasing in future years; and
6	WHEREAS, in recent years, Louisiana has made changes to the delivery of health
7	care through the establishing of hospital public-private partnerships and establishing
8	Medicaid managed care; and
9	WHEREAS, developing a comprehensive financial plan to pay for health care
10	services in the upcoming years with decreasing federal financial support is a prudent and
11	responsible step.
12	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
13	direct the Department of Health and Hospitals to create a working group to study and
14	research the future of health care funding in Louisiana and report its findings to the
15	legislature.
16	BE IT FURTHER RESOLVED that the working group shall be staffed by the
17	Department of Health and Hospitals.
18	BE IT FURTHER RESOLVED that the working group be comprised of the

1	following members:
2	(1) The secretary of the Department of Health and Hospitals or his designee.
3	(2) The executive director of the Louisiana Association of Health Plans or his
4	designee.
5	(3) The executive director of the Louisiana Hospital Association or his designee.
6	(4) The chief executive of the Louisiana State Medical Society or his designee.
7	(5) The president of the Public Affairs Research Council of Louisiana or his
8	designee.
9	BE IT FURTHER RESOLVED that the members of the working group shall serve
10	without compensation except per diem or expense reimbursement to which they may be
11	individually entitled as members of their organizations.
12	BE IT FURTHER RESOLVED that the secretary of the Department of Health and
13	Hospitals or his designee shall serve as the chairperson of the working group.
14	BE IT FURTHER RESOLVED that the chairperson of the working group shall call
15	the first meeting of the working group no later than September 1, 2014.
16	BE IT FURTHER RESOLVED that a majority of the total membership of the
17	working group shall constitute a quorum of the working group, and any official action by the
18	working group shall require an affirmative vote of a majority of the quorum present and
19	voting.
20	BE IT FURTHER RESOLVED that the working group may conduct such meetings
21	at such times as it deems necessary or convenient to enable it to exercise fully and
22	effectively its powers, perform its duties, and accomplish the objectives and purposes of this
23	Resolution.
24	BE IT FURTHER RESOLVED that the working group shall make a report of its
25	work and findings and shall submit the report to the legislature no later than sixty days prior
26	to the convening of the 2015 Regular Session of the legislature.
27	BE IT FURTHER RESOLVED that the legislative authority for the working group
28	shall terminate on March 1, 2015.
29	BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
30	secretary of the Department of Health and Hospitals, the executive director of the Louisiana
