PROCUREMENT CODE. Provides for lowest available price for certain software procurement contracts. (7/1/14)

AN ACT

2	To amend and reenact R.S. 39:199(D), relative to methods of procurement; to provide for
3	the lowest available price for certain software procurement contracts; to provide for
4	an effective date; and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 39:199(D) is hereby amended and reenacted to read as follows:
7	§199. Methods of procurement
8	* * *
9	D.(1) Method for procuring software and software maintenance and support
10	services. Notwithstanding any other provisions of this Part, any agency may procure
11	data processing software, software maintenance, and support services without the
12	need for competitive bidding. Such procurement must have the written advance
13	approval of the state central purchasing agency and shall not be for a price greater
14	than the vendor's published price.
15	(2) Additionally, any agency seeking to procure a new contract, a
16	contract extension of an existing contract, or any other contract modification
17	for software, software maintenance, and support services shall show evidence

1	that the price received or negotiated is the lowest available price by exhibiting
2	prices that may appear in a catalog, price list, schedule, on the Internet, or other
3	form that:
4	(a) Is regularly maintained by a vendor or other contractor.
5	(b) Is either published or otherwise available for inspection by
6	customers.
7	(c) Is available through inquiries with other states or local governments
8	using similar products and services.
9	(d) Is available through statements of prices on the Internet and are
10	currently or were last made to a significant number of buyers constituting the
11	general buying public for the software or services involved.
12	(3) In the event that the lowest available price can not be obtained in the
13	form or source as specified in Subparagraphs (a) through (d) of this Paragraph,
14	the agency seeking to procure a new contract, a contract extension of an existing
15	contract, or any other contract modification for software, software
16	maintenance, and support services shall require the vendor to certify in writing
17	that the price received is the lowest price available to other states or local
18	governments for similar products and services at the time the quote is
19	submitted.
20	(4) The procurement support team shall develop and deliver to the office of
21	state purchasing and the office of information technology proposed rules establishing
22	guidelines for procurement activities under this Part. Upon approval of the office of
23	information technology, the office of state purchasing shall promulgate rules in
24	accordance with the Administrative Procedure Act.
25	Section 2. This Act shall become effective on July 1, 2014; if vetoed by the
26	governor and subsequently approved by the legislature, this Act shall become
27	effective on July 1, 2014, or on the day following such approval by the legislature.

DIGEST

Mills (SB 409)

Present law provides for methods of data processing procurement.

<u>Present law</u> provides that any state agency may procure data processing software, software maintenance, and support services without competitive bidding, provided such procurement has written advance approval from the state central purchasing agency and is not for a price greater than the vendor's published price. Also provides for the use of a procurement support team in the promulgation of rules relative to such procurement.

<u>Proposed law</u> retains <u>present law</u> and further provides that any agency seeking to procure a new contract, a contract extension, or any other contract modification for software, software maintenance, and support services must show that the price received or negotiated is the lowest available price by exhibiting prices that may appear in a catalog, price list, schedule, Internet, or other form.

<u>Proposed law</u> further provides that such prices must be from a source that is regularly maintained by a vendor or other contractor, is either published or otherwise available for inspection by customers, is available through inquiries with other state or local governments using similar products and services, and is available through statements of prices on the Internet and are currently or were last made to a significant number of buyers constituting the general buying public for the software or services involved.

<u>Proposed law</u> further provides that in the event the lowest available price can not be obtained in the form or source specified in the <u>proposed law</u>, the agency seeking to procure a new contract, a contract extension of an existing contract, or any other contract modification for software, software maintenance, and support services shall require the vendor to certify in writing that the price received is the lowest price available to other states or local governments for similar products and services at the time the quote is submitted.

Effective July 1, 2014.

Summary of Amendments Adopted by Senate

Committee Amendments Proposed by Senate Committee on Finance to the original bill

- 1. Adds stipulation that in the event the lowest available price can not be obtained in the form or source specified in the proposed law, the agency seeking to procure a new contract, a contract extension of an existing contract, or any other contract modification for software, software maintenance, and support services shall require the vendor to certify in writing that the price received is the lowest price available to other states or local governments for similar products and services at the time the quote is submitted.
