AGRICULTURE/MILK: Provides relative to the sale or distribution of raw milk by a farmer to a consumer

| 11 | Section 1. R.S. 40:921(A) and 922(A) are hereby amended and reenacted and                 |
| 12 | Subpart C of Part VII of Chapter 4 of Title 40 of the Louisiana Revised Statutes of 1950, |
| 13 | comprised of R.S. 40:931 through 938, is hereby enacted to read as follows:               |
| 14 | §921. Grade A requirements; powdered whole milk and powdered skim milk                    |

| 16 | A. All Except for the sale of raw milk pursuant to R.S. 40:931 et seq., all               |
| 17 | fluid milk, cream, buttermilk, and milk beverages sold, offered for sale, or delivered    |
| 18 | for the purpose of human consumption as such, shall be Grade A according to               |
| 19 | specifications in the rules and regulations promulgated by the Department of Health       |
| 20 | and Hospitals, hereinafter referred to as the "department"; provided that a person        |

| 4  | §922. Rules and regulations prescribing sanitary standard requirements and grade         |
| 5  | labeling requirements                                                                    |
| 6  | A. The department is hereby empowered and shall hereby have the authority                |
| 7  | to promulgate rules and regulations prescribing the sanitary standard requirements       |
| 8  | of all milk sold or offered for sale in this state, other than raw milk sold pursuant to |
| 9  | R.S. 40:931 et seq., provided that no rules and regulations shall be promulgated         |
| 10 | setting up standards lower than those as set forth in the U.S. Public Health Service     |
| 11 | Milk Ordinance and Code.                                                                 |

| 13 | SUBPART C. SALE OF RAW MILK FOR HUMAN CONSUMPTION                                        |
| 14 | §931. Definitions                                                                        |
| 15 | In this Subpart, unless the context otherwise requires, the following                    |
| 16 | definitions shall be applicable:                                                         |
| 17 | (1) "Incidental sales of goat milk and whole milk that has not been                      |
| 18 | pasteurized" means those sales where the average monthly number of gallons sold          |
| 19 | does not exceed five hundred gallons.                                                    |
| 20 | (2) "Raw milk" means goat milk and whole milk that has not been                          |
| 21 | pasteurized.                                                                             |
| 22 | (3) "Whole milk" means the lacteal secretion obtained by the complete                    |
| 23 | milking of one or more healthy cows, properly fed and kept, that when offered for        |
| 24 | sale contains at least three and one-fourth percent of butterfat and eight and           |
| 25 | one-fourth percent solids not fat. The term "whole milk" shall not include lacteal       |
| 26 | secretion obtained within fifteen days before or five days after calving or a longer     |
| 27 | period if necessary to render the milk practically colostrum free.                       |

| 3  | A. Notwithstanding any provision of law to the contrary, nothing in this Part           |
| 4  | shall be construed to prohibit incidental sales of goat milk or whole milk that has not |
| 5  | been pasteurized, for the purpose of human consumption, directly to consumers by        |
| 6  | the farm where the milk is produced if the farm is registered pursuant to Subsection    |
| 7  | C of this Section, or to preclude the advertising of incidental sales of goat milk or   |
| 8  | whole milk that has not been pasteurized.                                               |
| 9  | B. Information describing the standards used by the farm or dairy with                  |
| 10 | respect to the production of raw goat milk or whole milk shall be provided to the       |
| 11 | consumer by the farmer together with results of tests performed on the milk and the     |
| 12 | animals that produced the milk, and an explanation of the tests and test results.       |
| 13 | C. Registration of a farm or dairy as required by Subsection A of this Section          |
| 14 | shall be accomplished by delivering to the Department of Health and Hospitals a         |
| 15 | written statement containing all of the following information:                          |
| 16 | (1) The name of the farmer, farm, or dairy.                                             |
| 17 | (2) A valid, current address of the farmer, farm, or dairy.                             |
| 18 | (3) A statement that raw milk is being produced at the farm or dairy.                   |
| 19 | D. With respect to goat milk or whole milk that has not been pasteurized, the           |
| 20 | seller shall do all of the following:                                                   |
| 21 | (1) Post at the point of sale a sign that is no smaller than two feet by four feet      |
| 22 | that includes all of the following information in large, clear text:                    |
| 23 | (a) The name and address of the farm with the seller's contact information.             |
| 24 | (b) The following statement: "This product, sold for personal use and not               |
| 25 | for resale, is raw milk that has NOT been pasteurized. The raw milk sold by this        |
| 26 | farm has been inspected by the state of Louisiana."                                     |
| 27 | (2) Affix a label to the bottle or package that includes all of the following           |
| 28 | information:                                                                            |
| 29 | (a) The name and address of the farm with the seller's contact information.             |

| 7  | F. After registering with the department, the farm shall receive and pass all       |
| 8  | inspections required by the department.                                             |
| 9  | §933. Chemical, bacteriological, and temperature standards                          |
| 10 | All raw milk produced for human consumption pursuant to this Subpart shall          |
| 11 | conform with all of the following chemical, bacteriological, and temperature        |
| 12 | standards:                                                                          |
| 13 | (1) No process or manipulation other than appropriate refrigeration shall be        |
| 14 | applied to milk for the purpose of removing or deactivating microorganisms.         |
| 15 | (2) The milk shall be temperature cooled to forty degrees Fahrenheit or less        |
| 16 | immediately after being drawn at the first milking. The milk shall be maintained at |
| 17 | that temperature, including during packaging and transportation, provided that the  |
| 18 | blend temperature after the first and subsequent milkings does not exceed forty     |
| 19 | degrees Fahrenheit.                                                                 |
| 20 | (3) Bacterial limits. Raw milk shall not exceed fifteen thousand per                |
| 21 | milliliter.                                                                         |
| 22 | (4) Drug residue tests on the milk shall be conducted at least two times            |
| 23 | during any consecutive six months. There shall be no positive results on drug       |
| 24 | residue detection methods.                                                          |
| 25 | (5) Somatic cell. Raw milk count shall not exceed the federal limit.                |
| 26 | (6) Coliform. Raw milk shall not exceed ten per gram.                               |
| 27 | (7) Pathogenic organisms. Individual producer milk shall not exceed zero            |
| 28 | organisms including but not limited to the following:                               |
| 29 | (a) Escherichia coli 0157:H7.                                                       |

| 4  | §934. Sanitation                                                                       |
| 5  | All raw milk produced for human consumption pursuant to this Subpart shall             |
| 6  | conform with all of the following sanitation requirements.                             |
| 7  | (1) Milk with abnormalities:                                                           |
| 8  | (a) Lactating animals which show evidence of the secretion of milk with                |
| 9  | abnormalities in one or more quarters, based upon bacteriological, chemical, or        |
| 10 | physical examination, shall be milked last or with separate equipment and the milk     |
| 11 | shall be discarded.                                                                    |
| 12 | (b) Lactating animals that have been treated with, or have consumed,                   |
| 13 | chemical, medicinal, or radioactive agents, which are capable of being secreted in     |
| 14 | the milk and which may be deleterious to human health, shall be milked last or with    |
| 15 | separate equipment and the milk shall be discarded.                                    |
| 16 | (c) Milk from lactating animals being treated with medicinal agents, which             |
| 17 | are capable of being secreted in the milk, shall not be offered for such period as is  |
| 18 | recommended by the attending veterinarian or as indicated on the package label of      |
| 19 | the medicinal agent.                                                                   |
| 20 | (d) Milk from lactating animals treated with or exposed to insecticides not            |
| 21 | approved for use on dairy animals by the United States Environmental Protection        |
| 22 | Agency shall not be offered.                                                           |
| 23 | (e) Bloody, stringy, off-colored milk or milk that is abnormal to sight or             |
| 24 | odor, shall be handled and disposed of as to preclude the infection of other lactating |
| 25 | animals and the contamination of milk utensils.                                        |
| 26 | (f)(i) Lactating animals secreting milk with abnormalities shall be milked             |
| 27 | last or in separate equipment which effectively prevents the contamination of the      |
| 28 | wholesome supply.                                                                      |

| 1  | (ii) Milking equipment used on animals with abnormalities in their milk shall           |
|----|-----------------------------------------------------------------------------------------|
| 2  | be maintained clean to reduce the possibility of re-infection or cross-infection of the |
| 3  | dairy animals.                                                                          |
| 4  | (g) Equipment, utensils, and containers used for the handling of milk with              |
| 5  | abnormalities shall not be used for the handling of milk to be distributed, unless they |
| 6  | are first cleaned and effectively sanitized.                                            |
| 7  | (h)(i) Processed animal waste derivatives used as a feed ingredient for any             |
| 8  | portion of the total ration of the lactating dairy animal shall be properly processed   |
| 9  | in accordance with at least those requirements contained in the Model Regulations       |
| 10 | for Processed Animal Wastes developed by the Association of American Feed               |
| 11 | Control Officials and shall not contain levels of deleterious substances, harmful       |
| 12 | pathogenic organisms, or other toxic substances which are secreted in the milk at any   |
| 13 | level that may be deleterious to human health.                                          |
| 14 | (ii) Unprocessed poultry litter and unprocessed recycled animal body                    |
| 15 | discharges shall not be fed to lactating dairy animals.                                 |
| 16 | (2) Milking barn or parlor construction:                                                |
| 17 | (a) A milking barn or parlor shall be provided on all farms or dairies in               |
| 18 | which the milking herd shall be housed during milking time operations.                  |
| 19 | (b) All floors shall be constructed of concrete or equal impervious material.           |
| 20 | Convalescent or maternity pens located in milking areas of stanchion-type barns may     |
| 21 | be used when they comply with the guidelines specified in Appendix C of the Grade       |
| 22 | A Pasteurized Milk Ordinance. Floors shall be easily cleaned and shall be graded        |
| 23 | to drain. Floors shall also be maintained in good repair and free of excessive breaks   |
| 24 | or worn areas that may create pools.                                                    |
| 25 | (c)(i) Walls and ceilings shall be smooth, painted, or finished in an approved          |
| 26 | manner, and in good repair. Ceilings shall be dust-tight.                               |
| 27 | (ii) Approved materials include wood, tile, smooth-surfaced concrete,                   |
| 28 | cement plaster, brick, or other equivalent materials with light colored surfaces.       |

| 2  | good repair. Surfaces shall be refinished whenever wear or discoloration is evident.     |

| 3  | (iv) Whenever feed is stored overhead, ceilings shall be constructed to                  |
| 4  | prevent the sifting of chaff and dust into the milking barn, stable, or parlor. If a hay |
| 5  | opening is provided from the loft into the milking portion of the barn, the opening      |
| 6  | shall be provided with a dust-tight door which shall be kept closed during milking       |
| 7  | operations.                                                                              |
| 8  | (d) Separate stalls or pens for horses, calves, and bulls shall be provided.             |
| 9  | The portions of the barn that are not separated by tight partitions shall comply with    |
| 10 | all requirements of this Section.                                                        |
| 11 | (e) Natural or artificial light well distributed for day or night milking shall          |
| 12 | be provided to ensure that all surfaces and particularly the working areas will be       |
| 13 | plainly visible. The equivalent of at least ten foot-candles, or one hundred ten lux,    |
| 14 | of light in all working areas shall be provided.                                         |
| 15 | (f) Sufficient air space and air circulation to prevent condensation and                 |
| 16 | excessive odors shall be provided.                                                       |
| 17 | (g)(i) There shall be no overcrowding which will be evidenced by the                     |
| 18 | presence of calves, cows, or other barnyard animals in walks or feed alleys.             |
| 19 | (ii) Inadequate ventilation and excessive odors may also be evidence of an               |
| 20 | overcrowded barn.                                                                        |
| 21 | (iii) Pit areas in parlors shall be at least six feet wide from the overhang             |
| 22 | when cows are milked on two sides, and shall have six feet working areas when there      |
| 23 | is a single row of stalls.                                                               |
| 24 | (iv) Ceiling height shall be at least seven feet in areas where cows stand.              |
| 25 | (h) There shall be dust-tight covered boxes or bins, or separate storage                 |
| 26 | facilities for ground, chopped, or concentrated feed. A dust-tight partition, provided   |
| 27 | with doors that are kept closed except when in actual use, shall separate the milking    |
| 28 | portion of the barn from any feed room or silo in which feed is ground or mixed, or      |
| 29 | in which sweet feed is stored. Lactating animal-housing areas or stables without         |
|    |                                                                                          |

(iii) Walls, partitions, doors, shelves, windows, and ceilings shall be kept in

| 1  | stanchions, such as loose housing stables, pen stables, resting barns, free stall barns, |

| 5  | (a) The interior of the milking barn, stable, or parlor shall be kept clean.             |
| 6  | Floors, walls, ceilings, windows, pipelines, and equipment shall be free of filth and    |
| 7  | litter and shall be clean. Outside surfaces of pipeline systems located in the milking   |
| 8  | barn, stable, or parlor shall be kept reasonably clean.                                  |
| 9  | (b) Gutter cleaners shall be kept reasonably clean.                                      |
| 10 | (c) Swine and fowl shall be kept out of the milking barn.                                |
| 11 | (d) All pens, calf stalls, and bull pens, if not separated from the milking barn,        |
| 12 | stable, or parlor, shall be kept clean.                                                  |
| 13 | (e) Feed shall be stored in a manner that will not increase the dust content             |
| 14 | of the air or interfere with the cleaning of the floor, such as in covered, dust-tight   |
| 15 | boxes or bins. Open feed dollies or carts may be used for distributing the feed, but     |
| 16 | not storing food, in the milking area.                                                   |
| 17 | (f) Milk stools, surcingles, and antikickers shall be kept clean and stored              |
| 18 | above the floor in a clean place in the milking barn, stable, parlor, or milkhouse,      |
| 19 | when not in use.                                                                         |
| 20 | (g) Food mangers shall be kept clean so as not to attract flies. Leftover feed           |
| 21 | in feed mangers shall appear fresh and not be wet or soggy.                              |
| 22 | (4) Cowyard:                                                                             |
| 23 | (a) The cowyard, which is interpreted to be the enclosed or unenclosed area              |
| 24 | approximately adjacent to the milking barn in which the lactating animals may            |
| 25 | congregate, including animal-housing areas and feed lots, shall be graded and            |
| 26 | drained and shall have no standing pools of water or accumulations of organic            |
| 27 | wastes.                                                                                  |
| 28 | (b) Wastes from the barn or milkhouse shall not be allowed to pool in the                |
| 29 | cowyard. Depressions and soggy areas shall be filled, and lactating animal lanes         |

| 2  | considered a violation of this Paragraph.                                              |

| 3  | (c) Manure, soiled bedding, and waste feed shall not be stored or permitted            |
| 4  | to accumulate in such a manner as to permit the soiling of lactating animals' udders   |

| 6  | loose-housing stables, pen stables, resting barns, holding barns, loafing sheds,       |
| 7  | wandering sheds, or free-stall housing shall be considered part of the cowyard.        |
| 8  | Manure packs shall be solid to the footing of the animal.                              |
| 9  | (d) In loafing or lactating animal housing areas, lactating animal droppings           |
| 10 | and soiled bedding shall be removed, or clean bedding added, at sufficiently frequent  |
| 11 | intervals to prevent the soiling of the lactating animal's udder and flanks.           |
| 12 | (e) Cooling ponds shall be allowed provided they are constructed and                   |
| 13 | maintained in a manner that does not result in the visible soiling of flanks, udders,  |
| 14 | bellies, and tails of lactating animals exiting the pond.                              |
| 15 | (f) Waste feed shall not be allowed to accumulate.                                     |
| 16 | (g) Swine shall be kept out of the cowyard.                                            |
| 17 | (5) Milkhouse or room construction and facilities:                                     |
| 18 | (a) A separate milkhouse or room of sufficient size shall be provided, in              |
| 19 | which the cooling, handling, and storing of milk and the washing, sanitizing, and      |
| 20 | storing of milk containers and utensils shall be conducted, except as provided for in  |
| 21 | Paragraph (12) of this Section.                                                        |
| 22 | (b) The milkhouse shall be provided with a smooth floor constructed of                 |
| 23 | concrete or equally impervious material graded to drain and maintained in good         |
| 24 | repair. Floors shall be sloped to drains so that there are no pools of standing water. |
| 25 | Liquid waste shall be disposed of in a sanitary manner and all floor drains shall be   |
| 26 | accessible and shall be trapped if connected to a sanitary sewer system.               |
| 27 | (c) The joints between floors and walls shall be watertight.                           |
| 28 | (d) The walls and ceilings shall be constructed of smooth material, in good            |
| 29 | repair, well painted, or finished in an equally suitable manner. Surfaces and joints   |

kept reasonably dry. Cowyards which are muddy due to recent rains shall not be

shall be tight and smooth. Acceptable materials include sheet metal, tile, cement

| 3  | up to splash height shall be nonabsorbent and easily cleanable.                       |
| 4  | (e) The milkhouse shall have adequate natural or artificial light and be well         |
| 5  | ventilated. A minimum of twenty foot-candles, or two hundred twenty lux, of light     |
| 6  | shall be provided at all working areas from natural or artificial light for milkhouse |
| 7  | operations.                                                                           |
| 8  | (f)(i) A vestibule, if used, shall comply with the applicable milkhouse               |
| 9  | construction requirements.                                                            |
| 10 | (ii) Screened vents in the wall between the milkhouse and a breezeway,                |
| 11 | which separates the milkhouse from the milking parlor, are permitted, provided        |
| 12 | animals are not housed within the milking facility.                                   |
| 13 | (g) Water under pressure shall be piped into the milkhouse.                           |
| 14 | (h) The milkhouse shall be adequately ventilated to minimize odors and                |
| 15 | condensation on floors, walls, ceilings, and clean utensils.                          |
| 16 | (i) Vents, if installed, and lighting fixtures shall be located to preclude the       |
| 17 | contamination of bulk milk tanks or clean utensil storage area.                       |
| 18 | (j) The milkhouse shall be equipped with a wash-and-rinse vat having at               |
| 19 | least two compartments. Each compartment shall be of sufficient size to               |
| 20 | accommodate the largest utensil or container used. The cleaning-in-place vat for      |
| 21 | milk pipelines and milk machines may be accepted as one part of the                   |
| 22 | two-compartment vat, provided that the cleaning-in-place station rack in or on the    |
| 23 | vat and milking machine inflations and appurtenances are completely removed from      |
| 24 | the vat during the washing, rinsing, or sanitizing of other utensils and equipment.   |
| 25 | (k) Each milkhouse shall be provided with facilities for heating water in             |
| 26 | sufficient quantity and to such temperatures for the effective cleaning of all        |
| 27 | equipment and utensils.                                                               |
| 28 | (6) Milkhouse or room cleanliness:                                                    |

| 1  | (a) The floors, walls, ceilings, windows, tables, shelves, cabinets, wash vats,         |
|----|-----------------------------------------------------------------------------------------|
| 2  | nonproduct contact surfaces of milk containers, utensils, and equipment, and other      |
| 3  | milkhouse equipment shall be kept clean. Vestibules, if provided, shall be kept         |
| 4  | clean.                                                                                  |
| 5  | (b) Only articles directly related to milkhouse activities shall be permitted           |
| 6  | in the milkhouse.                                                                       |
| 7  | (c) The milkhouse shall be kept free of trash, animals, and fowl.                       |
| 8  | (d) Incidental articles such as desks, refrigerators, and storage cabinets may          |
| 9  | be in the milkhouse provided they are kept clean, ample space is available to conduct   |
| 10 | the normal operations in the milkhouse, and they will not cause contamination of the    |
| 11 | milk.                                                                                   |
| 12 | (7) Toilet facilities:                                                                  |
| 13 | (a) Every farm or dairy shall be provided with one or more toilets,                     |
| 14 | conveniently located and properly constructed, operated, maintained, and utilized in    |
| 15 | a sanitary manner. There shall be at least one flush toilet connected to a public sewer |
| 16 | system or to an individual sewage-disposal system or a chemical toilet, earth pit       |
| 17 | privy, or other type of privy.                                                          |
| 18 | (b) The waste shall be inaccessible to flies and shall not pollute the soil             |
| 19 | surface or contaminate any water supply. Vents of earth pits shall be screened.         |
| 20 | (c) No privy shall open directly into the milkhouse.                                    |
| 21 | (d) The toilet room, including all fixtures and facilities, shall be kept clean         |
| 22 | and free of insects and odors.                                                          |
| 23 | (e) Where flush toilets are used, doors to toilet rooms shall be tight and              |
| 24 | self-closing. All outer openings in toilet rooms shall be screened or otherwise         |
| 25 | protected against the entrance of insects.                                              |
| 26 | (8) Water supply:                                                                       |
| 27 | (a) Water for milkhouse and milking operations shall be from an approved                |
| 28 | supply properly located, protected, and operated, and shall be easily accessible,       |
| 29 | adequate, and of a safe, sanitary quality.                                              |

| 1  | (b) No cross-connection shall exist between a safe water supply and any               |
|----|---------------------------------------------------------------------------------------|
| 2  | unsafe or questionable water supply, or any other source of pollution.                |
| 3  | (c) There shall be no submerged inlets through which a safe water supply              |
| 4  | may be contaminated.                                                                  |
| 5  | (d) The well or other source of water shall be located and constructed in such        |
| 6  | a manner that neither underground nor surface contamination from any sewerage         |
| 7  | systems, privy, or other source of pollution can reach such water supply.             |
| 8  | (e) New individual water supplies and water supply systems that have been             |
| 9  | repaired or otherwise become contaminated shall be thoroughly disinfected before      |
| 10 | being placed in use. The supply shall be made free of the disinfectant by pumping     |
| 11 | to waste before any sample for bacteriological testing shall be collected.            |
| 12 | (f)(i) All containers and tanks used in the transportation of water shall be          |
| 13 | sealed and protected from possible contamination. The containers and tanks shall      |
| 14 | be subjected to a thorough cleaning and a bacteriological treatment prior to filling  |
| 15 | with potable water to be used at the farm or dairy.                                   |

Ortego HB No. 1279

**Abstract:** Authorizes the sale of goat milk or whole milk that has not been pasteurized by the producer to the consumer by the farm where the raw milk is produced.

<u>Present law</u> requires all fluid milk, cream, buttermilk, and milk beverages sold, offered for sale, or delivered for the purpose of human consumption to be Grade A according to specifications in the rules and regulations promulgated by the Dept. of Health and Hospitals (DHH).

<u>Proposed law</u> retains <u>present law</u> but adds an exception for raw milk sold pursuant to <u>proposed law</u>.

ENGROSSED HB NO. 1279

<u>Proposed law</u> defines "incidental sales of goat milk and whole milk that has not been pasteurized" as those sales where the average monthly number of gallons sold does not exceed 500 gallons.

Proposed law defines "raw milk" as goat milk and whole milk that has not been pasteurized.

<u>Proposed law</u> defines "whole milk" as the lacteal secretion obtained by the complete milking of one or more healthy cows, properly fed and kept, that when offered for sale contains at least 3-1/4% of butterfat and 8-1/4% solids not fat.

<u>Proposed law provides</u> that the term "whole milk" shall not include lacteal secretion obtained within 15 days before or five days after calving or a longer period if necessary to render the milk practically colostrum free.

<u>Proposed law</u> provides that nothing in <u>proposed law</u> shall be construed to prohibit incidental sales of goat milk or whole milk that has not been pasteurized directly to consumers by the farm where the milk is produced if the farm is registered pursuant to <u>proposed law</u> or to preclude the advertising of incidental sales of goat milk or whole milk that has not been pasteurized.

<u>Proposed law</u> provides that information describing the standards used by the farm or dairy with respect to the production of raw milk is provided to the consumer by the farmer together with results of tests performed on the animals that produced the milk, tests performed on the milk, and an explanation of the tests and test results.

<u>Proposed law</u> requires a farm or dairy to register by delivering to the Dept. of Health and Hospitals a written statement containing all of the following information:

- (1) The name of the farmer, farm, or dairy.
- (2) A valid, current address of the farmer, farm, or dairy.
- (3) A statement that raw milk is being produced at the farm or dairy.

<u>Proposed law</u> requires the seller of goat milk or whole milk that has not been pasteurized to do all of the following:

- (1) Post at the point of sale a sign that is no smaller than two feet by four feet that includes all of the following information in large, clear text:
  - (a) The name and address of the farm with seller's contact information.
  - (b) The following statement: "This product, sold for personal use and not for resale, is raw milk that has NOT been pasteurized. The milk sold by this farm has been inspected by the state of La".
- (2) Affix a label to the bottle or package that includes all of the following information:
  - (a) The name and address of the farm with the seller's contact information.

(b) The following statement: "This product, sold for personal use and not for resale, is raw milk that has NOT been pasteurized. The milk sold by this farm has been inspected by the state of La."

<u>Proposed law</u> requires a farmer who sells fresh unpasteurized goat milk or whole milk to permit inspection of the farmer's cows or goats and barns by any customer upon request.

<u>Proposed law</u> requires that upon registration, a farm shall receive and pass all inspections required by the department.

<u>Proposed law</u> sets forth the chemical, bacteriological, and temperature standards for raw milk sold pursuant to <u>proposed law</u>.

Proposed law sets forth the sanitation standards for raw milk sold pursuant to proposed law.

<u>Proposed law</u> sets forth the health standards for animals producing the raw milk sold pursuant to <u>proposed law</u>.

<u>Proposed law</u> requires each producer of raw milk for human consumption pursuant to <u>proposed law</u> to develop and maintain procedures for the notification of regulatory officials, consumer notification, and product recall, and to implement any of these procedures as necessary with respect to any product for which the producer knows or has reason to believe circumstances exist that may adversely affect its safety for the consumer.

<u>Proposed law</u> prohibits a producer of raw milk from publishing any statement that implies approval or endorsement by the Dept. of Health and Hospitals.
